## **Program for Realizing Educational Potential (PREP)**

PREP at Northern Arizona University offers students from disadvantaged backgrounds the opportunity to prepare for a future career in the health professions. Selected participants will meet role models who also come from disadvantaged backgrounds, work with health professionals, participate in academic development, and get a head start in preparing for college.

This four-and-a-half-week summer program is held on the NAU campus Mondays through Saturdays, June 2 to July 3, 2018. Scholars receive up to a \$3,600 stipend that can be used toward housing, meals, and transportation to and from campus, and are required to participate in all planned activities. Upon completion of PREP and pre-requisite courses, the scholars are encouraged to apply to a health profession program. The program is sponsored by a federal grant from the Health Resources and Services Administration, #D18HP29041, called the Journey for Underrepresented Medical Professionals (JUMP).

We welcome you to complete the application for PREP. Please complete each item to the best of your knowledge. Because PREP is a pathway for students from disadvantaged backgrounds to work toward a future career in the health professions, applicants must provide documentation showing they are from a disadvantaged background. Incomplete applications will not be considered. Applications are due **Friday**, **February 16**, **2018**. Selected scholars will be notified by e-mail **Wednesday**, **March 7**, **2018**. Accepted scholars will then be invited for a mandatory campus orientation **Friday**, **May 18**, **2018**.

## A completed application includes the following components:

- Application form
- The following items will need to be submitted as attachments:
  - o Proof of current economic status and educational disadvantage
  - A copy of recent high school or college/university transcripts (unofficial is acceptable)
  - 2018-2019 FAFSA or 2016 income taxes
  - Current resume
  - 1-2 page, double spaced essay
- Parents signature is required on applications for all minors

Because PREP is a pathway for students from disadvantaged backgrounds to work toward a future career in the health professions, applicants must provide documentation showing they are from a disadvantaged background or from a community with a shortage of health care professionals. Scholars accepted to PREP must be both **Economically** and **Educationally Disadvantaged** as defined in the print below.

• **Economically disadvantaged**: Coming from a family with an annual income 200% below the federal poverty level in 2016. Please provide documentation showing family income is below the 200% poverty threshold.

Please provide one or more of the following documents to provide proof of low income:

- Letter from school stating student qualifies for free/reduced lunch
- FASFA Student Aid Report
- Copy of parent 2016 taxes

• **Educationally disadvantaged**: Coming from an environment that has inhibited the individual from obtaining the knowledge, skills, and abilities necessary to develop and participate in a health professions education or training program.

PREP scholars must provide documentation supporting an <u>Educational</u> <u>Disadvantage</u> in either the **Educational Background** or **Family Background** categories below.

## **Educational Background:**

- Attended an under-performing high school. Under-performing rating is high school specific, not rating for school district or state.
  - Arizona resident documentation can be your high school report card and high school Achievement Profile at: azreportcard.org
  - If you are not from Arizona, go to your state's Department of Education website and look for your high school report card.
  - A federal site that might provide information is: <u>nces.ed.gov/globalLocator/</u> Fill out your school information. A pop-up window will display school data, click "more Information" at the top for additional details (total students, free lunch & reduced lunch eligible data).
- · Graduated from or last attended a school with:
  - o Low SAT scores based on most recent data available
  - Low percentage of seniors receiving a high school diploma
  - o Low percentage of graduates going to college during their first year after graduation
  - Low per capita funding

## Family Background:

- Raised by single parent due to death of one parent. Must provide copy of death certificate.
- Family receives public aid such as food stamps, Medicaid/AHCCCS or other type of federal/ state insurance, public housing, free school lunch, etc. Attach letter from approved funding agency.
- Both parents' highest level of education is high school degree or lower. Documentation can be found on your FAFSA- Student Aid Report (SAR).
- Lived in an area that is considered by the Federal government as a rural area. See datawarehouse.hrsa.gov/tools/analyzers/geo/Rural.asp and enter the address where you were raised.
