## In Memory of our Beloved Members

Our condolences to the families of these NAU retirees, spouses, and faculty members who have recently passed away. (Information is from published obituaries). If you know of a retiree or spouse who has died, please contact Nydia Nittmann at Nydia.nittmann@nau.edu.

Robert Crozier (1927-2023) – A longtime member of the NAU and Flagstaff communities, Bob passed away at home on December 8, 2023. He was a native Arizonan, born in the Ft. Huachuca area. He attended Arizona State Teachers College at Flagstaff (now NAU) and was elected Homecoming King in 1952. He graduated in 1953 and served in the Army in Japan. Bob met his wife Joy while working at the Navajo Army Depot and they married in 1957. In 1967 he went to work for NAU as the Assistant Director of Career Placement and Alumni Secretary, eventually becoming the Assistant Director of University Development and the NAU Foundation Manager. He loved working with students, was an ambassador for NAU for more than 40 years, a devoted fan of NAU football and basketball, and was committed to his family, neighborhood, and community. He attracted kind and good people then surrounded them with his own kindness and compassion.

**Richard C. Hall (1939-2024)** - Passed on February 1, 2024 following a week in the ICU after taking a walk in the freezing rain, slipping on an icy patch, and breaking his neck. He began his NAU career a the first astronomy professor in 1965, teaching a class called Man in Space and holding labs on the roof of the chemistry building. He was always an outdoor guy, viewing the sky, planting his crops and berry bushes and running/bicycling/swimming whenever he could. He built a house for his family — and several boats for rowing on Lake Mary.

**Anne Elizabeth McGregor (1937-2023)** – Passed August 5, 2023, in Gardnerville, Nevada. Anne and her husband moved to the Navajo Reservation and worked at the Baby Rocks Trading Post for many years. When they moved to Flagstaff, Anne worked at NAU in the history department, registrars' office, and Cline Library. She retired in 2004. She is remembered as someone who always greeted you with a smile and a hug and is survived by many loving family members.

**Dr. Patricia Louise Bilby Moore (1948-2023)** – Passed August 13, 2023, in Phoenix, Arizona. Patty was a native Arizonan, born in Flagstaff. She attended all three state universities at various times and while working at NAU earned both her Master of Education in HR Relations (1992) and her Doctor of Education (2001). She retired in 2011 from her position as Associate Vice President of the NAU Extended Campuses. Patty enjoyed life discussing politics and exchanging ideas, various hobbies and activities, and took great joy from her collection of dolls and restoring antique doll houses. She gave regularly to a variety of charities and was a blessing and joy to all who knew her.

**Dr. Craig William Sidles (1934-2023)** – Passed November 27,2023 of congestive heart failure. He and his family moved to Flagstaff in 1968. He was chair of the NAU Department of Psychology and Educational Psychology. Craig was NAU homecoming dedicatee in 1978 and received an NAU President's Award in 1997. He was preceded in death by Mary Jane Sidles, his wife of 61 years.

**Susan Jay Thomas (1954-2023)** – After a two year trial with transverse myelitis, Susan passed July 3, 2023. She came to NAU in 1972 as a student from New Jersey. She ended her career as the first female Construction Management professor at NAU after many other firsts in her life. She is survived by her daughter Jenna and numerous family members.

**Dr. Bennett Zinnecker (1933-2023)** – Passed July 9, 2023, peacefully at his home in Peoria, Arizona. Ben began his NAU career in 1977 as the commander of the USAF ROTC program at NAU. After retiring from the Air Force, he was employed at the Center for Vocational Education and as an assistant to the president of NAU. He continued to advance his learning by earning a PhD in education from NAU in 1986. He provided volunteer service to his church and many civic service groups including NAURA. He was preceded in death by Jacy, his wife of 66 years. He is remembered as a person of great character and honesty.

### Travel Notes — Ireland

My husband and I got the opportunity to visit Ireland this past summer. Through our travel agent, we booked with CIE Tours and flew into Dublin to be whisked off past the American Embassy and tent city (yes, they have their own immigration problems) to Dun Laoghaire at the Royal Marine Hotel near the harbor, which was the original harbor for Dublin. There are wonderful restaurants in Dun Laoghaire, and we were able to have two nice dinners there, an Irish breakfast, and, of course, shopping. Once the tour really started, we



headed to St. Patrick's Cathedral and took in the beauty of the park surrounding the Cathedral, as well as the cathedral itself. That evening, we had a meet and greet dinner at the hotel.

The following day we headed out to Galway. One of the wonderful things of the CIE tour, was that they stopped every 90 minutes or so to allow for us to stretch our legs, use the restrooms, and shop. We stopped at Sean's Bar, located in Athlone, Co, which is the oldest pub in Ireland, dating back to the 1500's. We were treated to a pint of Guinness and some history of the pub. Once we reached Galway, we stopped at the center of town to head for lunch on our own and we stopped to have fish and chips on Guay Street, because you can't go wrong with fish and chips in Ireland. The most fantastic humous tour guide gave a tour of old Galway, which went through a mall in Eyre Square Center, as the mall was built upon a former castle. At the end of the tour was a memorial to President John F. Kennedy. That night led to a group dinner at the hotel which include scrumptious desserts.



From around Galway, we took a river tour out to the sea and headed to Kylemore Abbey and Connemara National Park. What a beautiful Abbey, which included a Victorian Walled Garden that was fabulous. We were able to have dinner at Murty Rabbit's Bar & Kitchen—established in 1872—for more pub food.

The next day was my highlight of the trip, where we got to watch sheep dogs herd the sheep and we had a lesson on sheep herding. I'm never going to be a sheep herder, but what amazing dogs! Now here's the real reason it was the highlight of the trip...we then headed to the Cliffs of Mohr, but it was so foggy, we only had 5 minutes when the cliffs were really visible. We did get much exercise climbing the steps.

Onto Killarney and a horse and buggy ride through the park and to the Ross Island Castle. We headed around the Ring of Kerry and saw the beautiful sights. We had dinner at Kate Kearney's Restaurant and were delighted to Irish music and dancing. It reminded of us of visitors in Flagstaff going to Black Bart's Steakhouse. We visited Kenmare and the Hawthorn Fairy Tree and again had a great pub lunch.

Of course, if you go to Ireland, you have to visit Blarney Castle and kiss the Blarney Stone. After climbing up to the top and waiting in line, I couldn't personally kiss the Blarney Stone, due to having to hang upside-down, which would have sent my vertigo into hyper-drive, but my husband kissed the stone. They do wash it off between kisses. Onto another pub, learning an Irish song, and having more Guinness.

Then it was off to Waterford and a tour of the Waterford Crystal Museum where they were working on the trophy for the Aer Lingus College Football Classic. When we got back home, we watched the presentation of the trophy on TV. What a tour! The following day we had a walking tour of Waterford, then headed to a tour of Kilkenny Castle and back to Dublin. It was an amazing 8-day tour that was jam packed with fun and adventure. I recommend this tour to anyone. We were blessed with a fantastic tour guide and bus driver. Since it was a small group tour, there was plenty of room on the bus to move around and it was truly wonderful to see the landscape. One of the interesting aspects of the CIE Tour was that you could do a self-driving tour and not have to ride on the bus, but be able to visit and have meals with all the bus folk.

Below are our first two Community Engagement stories.

#### Kathi Zahl - Volunteering with AARP Taxaide

When I retired, I didn't think about volunteering much. I was busy doing some traveling, exercising, and just having fun.

Three years ago, I started volunteering with AARP Taxaide. This program focuses on doing taxes for seniors for free, but we do taxes for anyone who makes an appointment. We are all certified by the IRS and the AARP Foundation and held to a very strict standard of conduct. Here in the Las Vegas/ Henderson valley we have 15 sites that file close to 7000 tax returns each year.

I started as a greeter, just meeting people and making sure they have their documentation with them. I then learned to be an intake person who goes through all the documentation with the taxpayer and organizes the information for the counselor who will do the actual tax return.

I am now the Scheduling Coordinator and I supervise the online/telephone scheduling process and 12 other schedulers. The team schedules appointments for our 15 sites from over 8000 phone messages. I work from home on my computer using Google Voice. I have also used my skills to create documents that schedulers use to help the taxpayer through the process of making, and being prepared for, their appointment. I find this volunteer work rewarding and most of the taxpayers are very grateful for this free service.

#### **Carole Mandino – Various**

As the former director of the Institute for Civic Engagement (now the Center for Service and Volunteerism), volunteering has always been an important part of my life. In 1970, to celebrate the upcoming Earth Day, I used my 12th birthday to have a party to pick up trash at a local park where I was raised. During my youth, I worked on political campaigns with my mother and volunteered to help fold and stuff envelopes for the organization in which she was involved. I found it fun, exciting, and a way of learning new information. I was very lucky to work with volunteers throughout my professional career.

As a retiree, there are days when I spend time at home, cleaning the house, or just watching the good ole boob tube. However, I didn't retire from civic life, and I believe we all have a civic duty to serve our community. Most days you can find me working on activities for Soroptimist International of the Arizona Peaks, a women's civic organization that empowers women and girls through education and assistance with education, or on the regional level as a district director, where I help other local clubs in our district working on things such as this article for the NAU Retirees Association, or reading materials for the City of Flagstaff Planning and Zoning Commission.

For Soroptimist, I am working on our fall fundraiser (September 8th), Sip-n-Stroll (a sophisticated pub crawl), and will be meeting with restaurants in the downtown area next week to get them to participate in our event. I am planning a luncheon in which we will be awarding almost \$7,000 divided between two women working on their educational goals to improve their lives. In April, I will be traveling to visit local Soroptimist clubs in Kingman, Lake Havasu City, Parker, and Blythe. For NAURA, it's a bit of a quiet time, so that's been nice, but we will be moving into our elections and our Spring luncheon in May--which I hope most of you will attend. For Planning and Zoning, after a busy summer and fall last year, it's also been a bit quiet as our last two meetings have been canceled.

On top of those activities, I do volunteer at the Flagstaff Family Food Center on the first Friday of each month and I also serve on the Coordinated Mobility Council for Northern Arizona that reviews information regarding transportation for older adults and those with disabilities.

Since NAURA is now located within the offices of the Center for Service and Volunteerism, our members can call and be helped to find an activity of volunteer interest. ## Legislative Update

The State Legislature began its 2nd Regular Session on January 8, 2023 and is scheduled to go at least for 100 days. Below are some highlights of bills being considered:

**Budget:** Current projected budget shortfall is \$1.7 billion over the next two years with two major causes being the 2.5% flat tax rate and the universal ESA voucher program. Governor Hobbs has proposed a 'balanced' budget by curbing eligibility for ESA programs, eliminating the School Tuition Organization tax credit program and cutting many one-time transportation programs.

**Elections/Voting Rights:** several bills are being considered related to early ballots, ballot processing, voting centers, political signs, cast vote records

**Health:** bills related to licensed health aides, hearing aids for children; random drug screening for group foster home employees

**Miscellaneous:** bills related to illegal border crossings; Diversity, Equity and Inclusion (DEI); utilities
