## Final Project Report

Project Archivist Matthew Smith prepared a processing plan for the El Malpais National Monument Archeological Survey 2000-2002. Approximately 9.7 linear feet of records were processed and arranged into appropriate series, file, and item level units. Document separation sheets were prepared (in accordance with the requirements of the *Processing and Cataloging Handbook*) for approximately 140 maps and oversized drawings.

Storage upgrade was completed for the processed collection. Documents were transferred into acid-free folders. Photographs, negatives and slide materials were rehoused in appropriate mylar enclosures and placed into binder boxes. Maps and oversized drawings were placed in an acid-free map folder. All items and boxes were labeled in accordance with the requirements of the *Processing and Cataloging Handbook*.
