Methods to File Complaints

The net price calculator provides estimated net price information (estimated cost of attendance minus estimated grant and scholarship aid) to current and prospective students and their families. Figures are based on what similar students paid in a previous year.

[Privacy of Student Records – Family Educational Rights and Privacy Act \(FERPA\)](#)

Responsible department: Office of the Registrar

The Family Educational Rights and Privacy Act (FERPA) of 1974 grants students the rights to inspect and review their education records, request an amendment to or challenge the accuracy of their records, prevent unauthorized disclosure of their records, contact to the U.S. Department of Education about a FERPA violation, and waive their FERPA rights in writing. FERPA mandates how educational records may be released and to whom, with or without the student's consent.

State Authorization is the process of gaining approval from other states to operate within their borders. The purpose of state authorization is consumer protection. Northern Arizona University participates in the National Council for State Authorization Reciprocity Agreements (NC-SARA). NAU is authorized to provide distance education, including online classes, continuing education opportunities, field trip experiences, and "experiential" activities to students located in other states that participate in NC-SARA. As of July 2023, Washington, D.C., Puerto Rico, the U.S. Virgin Islands, and all states except for California are members of NC-SARA. Students located in California can participate in NAU's distance education offerings.

Articulation agreements formally document transfer policies and practices between two or more colleges and universities documenting the transfer policies for a specific academic program or degree in general.

To meet the requirements of a particular degree plan, students may use transfer credit from other institutions. Transcripts are reviewed to determine the number of units accepted and how they will apply toward satisfying NAU General Studies, Inclusive Perspectives, major, minor and/or certificate requirements. Course equivalencies are established based on the alignment of learning outcomes and when the course was taken.

Students withdrawing or changing their residency classification will receive an appropriate tuition refund after all proper approvals and forms have been processed with the respective departments and Student and Departmental Account Services (SDAS) is notified. NAU complies with the Jeanne Clery Campus Safety Act, or "Clery Act"—a federal statute requiring all colleges and universities that participate in federal financial aid programs to compile crime statistics from their campuses and provide safety information.

The [Annual Security and Fire Safety Report](#) includes Clery reportable crime statistics for the three most recent completed calendar years and disclose procedures, practices, and programs the university uses to keep students and employees safe, including:

NAU releases its Fire Safety Report combined with the Clery Act – required Annual Security Report. The purpose of this report is to disclose fire safety policies and procedures related to on-campus student housing and to disclose statistics for reported fires that occurred in those facilities.

To safeguard the health of the NAU population, all new and transfer students attending the Flagstaff Mountain campus are required to provide proof of immunity to measles, mumps and rubella (MMR) – for all students born after December 31, 1956. Before a student can register, they are required to show proof of measles, mumps and rubella vaccinations or a lab test showing proof of immunity to the measles, mumps and rubella.

Missing Student Notification

Responsible department: Office of the Dean of Students

It is the policy of Northern Arizona University to investigate any report of a missing resident student (student who resides in on-campus student housing facilities). If NAUPD or AWCPD determine that a student can be designated a missing person, the Dean of Students or their designee will notify the student's designated contact person no later than 24 hours after the student is determined to be missing. If the student is under 18 years of age and not emancipated, the Dean of Students or their designee will also notify the student's custodial parent or guardian within 24 hours that the student is missing.

Student Financial Assistance

Arizona Student Loan Code of Conduct

Responsible department: Office of Scholarships and Financial Aid

This code of conduct was developed by the Arizona Attorney General's Office in conjunction with universities and colleges in the State of Arizona. NAU supports and complies with these provisions.

Assistance Available from Federal, State, Local, and Institutional Programs

Entrance Loan Counseling for Student Borrowers

Before receiving a disbursement of a Federal Direct Loan, the Federal Government requires students to complete entrance counseling to ensure that they understand the responsibilities and obligations they are assuming.

Exit Loan Counseling for Student Borrowers

Responsible department: Office of Scholarships and Financial Aid

Exit counseling provides important information to prepare student to repay their federal student

loan(s). Students who have received a subsidized, unsubsidized, or graduate PLUS loan under the Direct Loan Program must complete exit counseling each time they:

- Drop below half-time enrollment
- Graduate
- Withdraw from the university
