PROJECT INFORMATION

- With this RFQ, we are procuring Construction Manager at Risk (CMAR) services for renovations to mechanical systems at the Southwest Forest Science Complex ("Forestry") on the NAU Flagstaff Mountain Campus.
- Work will include an HVAC retrofit to replace existing boiler and wet-wall system and to connect the building to our South Campus centralized heating and cooling network.
- EAPC Architects Engineers is the selected Design Professional. They are working under NAU's ARQ contract. The Schematic Design package is nearing completion and the full Construction Documents will be issued by the end of December 2025.
