PART 1 – GENERAL

- A. Date of Issue: January 7, 2026
- B. The following Addendum shall be incorporated in the Contract Documents of the above-named job, and all requirements herein are fully a part of the Contract Documents as if included therein.
- C. Offerors shall acknowledge receipt of all Addenda in their Response to the Request for Qualifications, on *Attachment A: RFQ Submittal Certification Form*. Failure to do so may subject the Offeror to disqualification.

PART 2 – CLARIFICATIONS

1. **Question:** Criteria (I) Submittal Certification requires all submissions include “completed Attachment A and Attachment B (RFQ Submittal Certification and No Participation in Boycott of Israel Certification) found in Part II of this Request for Qualifications.” However, in the RFQ document, Attachment A is the project site map, and Attachment B includes the Submittal Certification form [*sic*]. Is the No Participation in Boycott of Israel Certification still required, and if so, can you please provide the appropriate form.
Response: *The No Boycott of Goods or Services from Israel Certification form was inadvertently excluded from the RFQ. The RFQ is amended as shown in PART 3 – ADDENDUM below to correct the reference to the Submittal Certification Form and to include a copy of the No Boycott of Goods or Services from Israel Certification form. All Offerors shall include a completed copy of the Submittal Certification (Attachment B) and No Boycott of Goods or Services from Israel Certification (Attachment F) with their Statement of Qualifications.*
2. **Question:** For (I) Submittal Certification – There is no Boycott of Israel form provided. Would you please provide? Thank you.
Response: *The No Boycott of Goods or Services from Israel Certification form was inadvertently excluded from the RFQ. The RFQ is amended as shown in PART 3 – ADDENDUM below to correct the reference to the Submittal Certification Form and to include a copy of the No Boycott of Goods or Services from Israel Certification form. All Offerors shall include a completed copy of the Submittal Certification (Attachment B) and No Boycott of Goods or Services from Israel Certification (Attachment F) with their Statement of Qualifications.*
3. **Question:** In Division IV - Selection Criteria - Section (I) Submittal Certification, the RFQ states “Include completed Attachment A and Attachment B (RFQ Submittal Certification and No

Participation in Boycott of Israel Certification) found in Part II of this Request for Qualifications,” but there is no form in the RFQ document labeled “No Participation in Boycott of Israel.” Additionally, the Submittal Certification is listed as Attachment B. Can you please clarify if you want only the Attachment B (RFQ Submittal Certification) completed and included in our submittal, or would you like us to include an additional form? If you would like us to include an additional form, can you please provide it? Thank you.

Response: *The No Boycott of Goods or Services from Israel Certification form was inadvertently excluded from the RFQ. The RFQ is amended as shown in PART 3 – ADDENDUM below to correct the reference to the Submittal Certification Form and to include a copy of the No Boycott of Goods or Services from Israel Certification form. All Offerors shall include a completed copy of the Submittal Certification (Attachment B) and No Boycott of Goods or Services from Israel Certification (Attachment F) with their Statement of Qualifications.*

4. **Question:** Can you please confirm the proposed location of the new nursing building? (Project No. 09.340.261). Is the building located on the Northern campus, adjacent to the Babbit [sic] Academic Annex, Peterson Hall and Educational Annex?

Response: *Please refer to the RFQ, DIVISION I – ADVERTISEMENT, paragraph three, which states that the new building will be situated in the center of the NAU Flagstaff campus in the area currently occupied by the Peterson Hall, Academic Annex, and Babbitt Academic Annex buildings. Additionally, DIVISION II – PROJECT DESCRIPTION AND SCOPE OF SERVICES, Project Location and Site Description includes information as to where the new building will be located. Furthermore, ATTACHMENT A: SITE LOCATION MAP shows the proposed location of the new building. The three existing structures on the proposed site will be demolished as part of this project, and the new building will be constructed on this site.*

5. **Question:** Also, can you confirm if the team is to disregard the proposed nursing building as described in the Smart Campus Master Plan from 2023 – relocated adjacent to the Health Professions building on the South Campus.

Response: *Since publication of NAU’s “Comprehensive Smart Sustainable Campus Master Plan” in October 2023, thinking has moved on as to the proposed location of the new building to be constructed under this project. The new building will be situated as noted in the RFQ and as confirmed in the response to Question 4 above.*

6. **Question:** Will the University be contracting independent of the design team for the assessment and abatement of the Peterson and Babbitt Academic Complex buildings? If not, could you share the FS-13 form (mentioned on page 5 of the following document: https://in.nau.edu/wp-content/uploads/sites/226/2025/05/Asbestos_O_And_M-5.2.25.pdf) with all parties?

Response: *The University will contract directly with an abatement contractor for required services as part of the demolition of the existing structures in order prepare the site for construction of the New Nursing Facility.*
