10. Question: Is the University facing challenges inherent to the current solution?

University's response: The current solution is outdated and minimally supported creating a significant risk in the ability to maintain compliance and provide value.

11. Question: Section 4.11.1., May we send a Non-Disclosure Agreement (NDA) for the University to review?

12. Question: Section 4.2.7., What WordPress features would the University like to retain?

University's response: The ability for University's departments to build webpages onto WordPress, which is the University web-hosting platform, will continue.

13. Question: Section 4.5.2: Does this refer to departmental charges, with department speedchart, account, being used to bill the payment back to the department?

University's response: Yes, and may also be used in integrating with PeopleSoft Financials. Refer to Section 4.5.3.

14. Question: Section 4.5.5: Does the University want to see how all fees are charged per individual transaction, per card type, per MID, or per TID?

University's response: Proposer to provide options for itemizing fees.

15. Question: Section 4.5.5: Is this section to gather reporting or is the University asking that bank transactions reflect reporting on a one to one (1:1) transaction basis?

University's response: Proposer to provide options for itemizing fees.
