1. <u>INTRODUCTION</u>

1.1. <u>University Background</u>. The University is a fully accredited State of Arizona institution of higher education. Additional information on the University is available at the following link <u>Quick Facts</u>.

1.2. Proposal Background.

The University is requesting sealed Proposals from qualified Proposers for a P3 Energy Advisor.

On Earth Day 2022, NAU President Cruz-Rivera declared a Climate Emergency and committed to heightened investments of the University time, talents, effort and resources to securing the conditions needed to achieve carbon neutrality for Scope 1 and 2 emissions by 2030. This goal of Carbon Neutrality by 2030 was institutionalized with the Arizona Board of Regents approval of the University's Elevating Excellence Strategic Plan in the summer of 2022. By the beginning of 2023, the Roadmap for Carbon Neutrality was approved. The University's Smart Sustainable Master Plan was approved in November 2023 that included district energy modernization and decarbonization.

The University is working towards decarbonization and seeking the expertise of an experienced advisory firm. The selected firm will aid in securing Public Private Partnership (P3) that will enable the University to modernize and decarbonize its district energy system and stand-alone gas infrastructure not connected to the district system. The selected P3 Advisor will lead the work through all phases which will include economic, technical, and contractual expertise across all asset classes and P3 markets. The University is seeking a firm that has a technical and engineering expertise related to energy and utilities, experience in revenue forecasting, insights into federal financial incentives, assistance with drafting specifications and evaluating P3 proposals and other alternative procurement methods, financing, and development activities. This strategic initiative aims not only to advance the University's progress to carbon neutrality but also to position the University as a leader in environmental stewardship.

The Flagstaff campus operates two central heating and cooling plants, one on north campus, and one on south campus. The north plant is a steam plant consisting of five steam boilers and three operable chillers. The south plant consists of three medium temperature hot water boilers and two chillers. Both plants operate year-round. The peak load for the combined plants is approximately 100,000,000 Btu/hour.

Steam and hot water piping is largely distributed through underground tunnels with some direct buried sections at end of line. Chilled water is almost exclusively distributed through direct buried lines. The north plant feeds steam to 52 buildings and chilled water to 33 buildings. The south plant feeds hot water to 13 buildings and chilled water to 6 buildings. The University has 162 facilities (6,912,811 GSF)

we heat and cool, the remaining of which rely on standalone boiler systems and often do not have cooling.

Emissions from the University distributed energy system and stand-alone heating and cooling amount to 42% of the university's total emissions. As part of our Climate Action Planning process between 2021-2022, an analysis of potential options for carbon neutral heating and cooling was conducted by Affiliated Engineers Inc (AEI). After evaluating a wide range of options, the plan identified two potential thermal solutions as Biomass or ground source heat pumps. These thermal strategies call for a conversion of both distribution systems to low-temperature hot water, connecting the north and south plant loops, and connecting standalone buildings to the distributed energy system where feasible.

Between 2020 and 2021, the University worked with the USDA's Wood Energy Technical Assistance Team to evaluate utilization of low value forest restoration biomass (e.g. small diameter trees, limbs etc.) for the district energy system conversion. They recommended a high efficiency, thermally led CHP with off-site wood storage that would utilize approximately 30,000 Bone Dry Tones (BDT)/year with the potential to generate significant power at a very low cost per unit. We have analyzed the lifecycle emissions profile of the use of restoration biomass and are confident in the carbon neutrality of burning biomass due to the alternative uses of biomass and the enhanced resiliency of our regional forests to the threat of catastrophic wildfire. The University and other partners in the region have evaluated the long-term biomass supply (forest residues, sawmill residues and woodland biomass) as over 400,000 bdt/yr of wood fiber within a 75-mile radius primarily from national forest lands that are part of the 4-Forest Restoration Initiative. The Bioeconomy Development Opportunity Zone Initiative recently concluded that 100,000bdt/yr were low-moderate risk and provided risk rating of an A for bioeconomy development.

The University also followed up on the AEI option of geothermal heat pumps. AEI oversaw the drilling of two test wells to better understand the heat flow in the local geology. One was drilled to a depth of 512 feet and another to 848 feet. These tests found limestone and sandstone with no water intrusion. The measured thermal conductivity was high with measures of 3.2-3.5 W/mK, significantly higher than the assumed conductivity of 1.3W/mK in the AEI climate Action Plan analysis and will allow for a smaller borefield to support this potential solution.

Preliminary analysis suggests that biomass or geothermal heat pumps appear to be the best solutions for our region, we do not want to lock potential P3 partners one single solution and are open to other decarbonization solutions, or combinations of technologies for the central plant and standalone buildings. We intend to be selective in the buildings that are connected to the district system by considering load and distance to existing infrastructure, as well as age and compatibility of the existing building infrastructure. Buildings not connected to the district system will need a carbon neutral heating conversion solution for this project.

The University is committed to pursuing this utility modernization and decarbonization strategy through a public-private partnership.

- 1.2.1. This RFP is part of a competitive negotiation process intended to allow the University to obtain goods and/or services as outlined herein in a manner that is most advantageous to the University.
- 1.2.2. This RFP provides the University the flexibility to negotiate with Proposers, if desired, to arrive at a mutually agreeable relationship. Price may weigh heavily in the evaluation process but will not be the only factor under consideration and may not be the determining factor. The Evaluation Criteria can be found in Section 8. All Proposals will be considered public records and will be available for review, as allowed by Arizona law and the Code.
- 1.2.3. It is the University's intent to select the Proposal(s), which are most favorable to the University in all respects, including scope, availability of services, quality of services, reputation, and price. If not otherwise stated herein, multiple Awards may be made or an Award(s) may be made partial, by part, by line item, or by any combination of parts if identified as being in the best interest of the University.
- 1.2.4. The initial Contract term will be for one (1) year with the possibility of four (4) successive one (1) year renewals, for a total term not to exceed five (5) years.
- 1.3. <u>Coverage and Participation.</u> Unless objection is submitted with the Proposal, it is the intent of the University that any Award resulting from the RFP be available for use by all departments of the University and any other Arizona University, along with any other educational institution or Governmental entities, to the extent allowed by Arizona law and the Code.

2. **DEFINITIONS**

Capitalized terms shall have the meaning set forth in Board Policy <u>3-801.B</u>, with the exception of the following terms which shall have the meanings set forth below in this RFP.

- 2.1. "ABOR" refers to the Arizona Board of Regents.
- 2.2. "May" or "Should" indicates something that is not mandatory but permissible/desirable. If a Proposer fails to provide recommended information, the University may, at its sole option, ask Proposer to provide the information or evaluate the Proposal without the information.
- 2.3. "Must," "shall," "will" indicates a mandatory requirement. Failure to meet any mandatory requirements may result, in the University's sole discretion, in the rejection of your proposal.
- 2.4. "MST" means Mountain Standard Time, the time zone in which the University operates. Arizona does not observe Daylight Savings Time.
- 2.5. "P3" refers to Public-Private Partnership.
- 2.6. "Procurement Documents" may refer to a Request for Proposal, Request for Information or a Request for Quote and corresponding documentation.
- 2.7. "Proprietary Information" means trade secrets and other proprietary or confidential information exempt from Arizona's Public Records Statute pursuant to A.R.S. § 15-1640(A). Contract terms and conditions, pricing, and information generally available to the public are not considered Proprietary Information under the Code (See Code § 3-801(D)(1)).
- 2.8. "RFI" refers to a request for information.
- 2.9. "RFP" refers to a request for proposals.
- 2.10. "RFQ" refers to a request for qualifications.
- 2.11. "Successful Proposer" means any Proposer selected by the University to receive an Award as a result of this RFP and to enter into a Contract to provide the University with the products or services sought by this RFP.

3. <u>INSTRUCTIONS TO PROPOSERS</u>

3.1. General Requirements.

- 3.1.1. The data, specifications, and requirements outlined herein are intended to serve as a general guideline for the University's requirements. Proposers should submit a fully detailed Proposal that adequately describes the advantages and benefits to the University. Proposers should provide a detailed response to each requirement in this RFP, individually numbered to match each requirement. At a minimum, in such case where a detailed response is not applicable, each Proposer should indicate their ability to comply with and/or agreement to the requirements of this RFP. Proposers are encouraged to provide any additional information that is not specifically identified in this RFP that would assist the University in making its evaluations based upon the disclosed evaluation criteria.
- 3.1.2. Any Person submitting a Proposal shall be deemed to have read and understand all the terms, conditions and requirements in this RFP.
- 3.1.3. The Contracts, Purchasing and Risk Management department shall retain this RFP, and all related terms and conditions, exhibits and other attachments, in original form in an archival copy. Any modification of these, in the Proposer's submission, is grounds for immediate disqualification.
- 3.1.4. Proposer agrees that the University will not pay for or be responsible for any cost or expense incurred by Proposer in the preparation, submission, presentation, or any other action connected with proposing or otherwise responding to this RFP.
- 3.1.5. The University reserves the right to reject any or all Proposals or any part thereof, or to accept any Proposal, or any part thereof, or to withhold the Award and to waive or decline to waive irregularities in any Proposal when it determines that it is in its best interest to do so. The University also reserves the right to hold all Proposals after the Opening date and the right to accept a Proposal not withdrawn before Opening.
- 3.1.6. Proposer may withdraw their Proposal any time prior to Opening. Proposer may request to withdraw their Proposal after Opening and any time prior to selection and notice of Award. The University shall have sole authority to grant or deny such a request. In the event the University grants such a request, it may withhold issuing future Requests for Proposals to such Proposer.
- 3.1.7. All Proposals and accompanying documentation will become the property of the University at the time the Proposals are opened. It will be the Proposer's responsibility to request that samples be returned to the Proposer and provide a method for doing so at the expense of the Proposer. If such a request is not received and a method of return is not provided, all samples shall become the property of the University forty-five (45) days from the date of Award and may be disposed of in the University's sole discretion.

- 3.1.8. Collusion with other Proposers or employees thereof, or with any employee of the University, is prohibited and may result in disqualification of the Proposer and/or cancellation of an Award. Any attempt by the Proposer, whether successful or not, to subvert or skirt the principles of open and fair competition may result in disqualification of Proposer and/or cancellation of an Award.
- 3.1.9. Each Proposer shall ensure that no improper, unethical, or illegal relationships or conflict of interest exists between or among the Proposer, the University, and any other party to this RFP. Without limiting the foregoing, Proposer shall refrain from offering or giving gratuities, in the form of entertainment, gifts or otherwise, to any officer or employee of the State of Arizona with a view toward securing a Contract or securing favorable treatment with respect to the awarding or amending, or the making of any determinations with respect to the performing of such Contract. The University reserves the right to determine the materiality of such relationships, when discovered or disclosed, whether intended or not; and to decide whether or not Proposer disqualification and/or cancellation of an Award shall result.
- 3.1.10. If any Proposer or any of the Proposer's employees, agents, or other representatives participating in this RFP need, or have questions about the University's accommodations for people with disabilities, arrangements can be made by contacting Debra Cisneros at telephone # 928-523-5285, email address Debra.Cisneros@nau.edu. Such requests should be made as early as possible to allow time to arrange the accommodation(s).
- 3.1.11. The University shall have the right to use any ideas that are contained in any Proposal received in response to this RFP, along with any adaptation of such ideas. Selection or rejection of the Proposal shall not affect the University's right of use. Provided, however, that the University will, in good faith, honor the proprietary and confidential nature of any Proposer information that is enclosed in a separate envelope from the Proposal and clearly designated and conspicuously labeled as set forth in Section 7.5.9 of this RFP.
- 3.1.12. Any protest of this procurement must comply with the requirements of section 3-809(B) of the Code.
- 3.1.13. Proposer shall acquire and maintain all necessary permits and licenses and shall adhere strictly to all Federal, State, County, or City laws, codes, regulations, and ordinances as applicable in performing any work under this RFP.
- 3.1.14. The University is under no obligation whatsoever to honor or observe any information that may apparently conflict with any provision of this RFP, regardless of whether such information is obtained from any office, agent, or employee of the University. Such information shall not affect the Proposer's risks or obligations under a Contract resulting from this RFP.
- 3.1.15. Any Proposer exception, stipulation, counter-offer, requirement, and/or other alternative term or condition shall be considered rejected unless specifically

- accepted in writing by the University and thereafter incorporated into any Contract resulting from this RFP.
- 3.2. Attention to Terms and Conditions. Proposers are cautioned to thoroughly understand and comply with all matters covered under the Terms and Conditions section of this RFP. The Successful Proposer is expected to enter into the form of agreement approved by the Board, refer to Section 9. The University terms and conditions included in this RFP, are intended to be incorporated into the Contract.

 Proposals that are contingent upon any changes to these mandatory terms and conditions may be deemed to be non-responsive and may be rejected.

 Proposals must state any exceptions taken to the mandatory terms and conditions in detail.

3.3. <u>Project Resources.</u>

- 3.3.1. The Successful Proposer shall be required to provide the personnel, knowledge, and experience required to maintain an appropriate level of professionalism and coverage for performance of requirements outlined herein. The University reserves the right to review Proposer's staff assigned for relevant qualifications and experience.
- 3.3.2. Proposals shall include a list of proposed personnel with resumes specifying qualifications and relevant experience. Describe assignment of account representatives and/or key personnel.
- 3.3.3. Proposer may subcontract installation, training, warranty, or maintenance service with prior University authorization. Proposal shall list and describe any subcontractor's qualifications and relevant experience and describe how Proposer guarantees subcontractor performance. The Successful Proposer shall remain solely responsible for the performance of a resulting Contract from this RFP. All University payments for goods and/or services shall be made directly to the Proposer.
- 3.3.4. The University reserves the right to inspect Proposer's facilities prior to Award or any time throughout the term of the Contract.
- 3.4. <u>Small Businesses</u>. The University is committed to the development of Small Business and Small Disadvantaged Business ("SB & SDB") suppliers. If subcontracting (Tier 2 and higher) is necessary, Proposer (Tier 1) will make commercially reasonable efforts to use SB & SDB in the performance of any Contract resulting from this RFP. Proposals should include a description of the Proposer's efforts to solicit SB & SDB participation in providing the services.

4. SCOPE OF WORK

The Award Proposer will play a pivotal role in shaping the University's path toward energy decarbonization through the development of a public-private partnership. The P3 Energy Advisor will facilitate the successful development of a P3 project/s to meet the University's decarbonization goal and serve as the University's third-party provider to assure strong technical and financial performance of a P3 partner.

4.1. Phases

The scope of work includes but not limited to the following phases and tasks. Proposers are invited to include additional tasks or steps that would be necessary to reach the university goals.

4.1.1. Phase One

- 4.1.1.1. Assist the University in determining the best progressive procurement strategy and develop specifications for a Request for Proposal.
- 4.1.1.2. Evaluate and compare the financial benefits, risks, and long-term cost savings associated with different procurement strategies to reach our goal.
- 4.1.1.3. Assist with procurement and P3 recommendations that reduce risk and ensure the best environmental and financial outcome for the University.
- 4.1.1.4. Provide guidance on partner selection, project delivery models, and strategic engagement with private stakeholders.
- 4.1.1.5. Assess current state of the University's knowledge and documentation and identify information gaps necessary for utility modernization and decarbonization options.
- 4.1.1.6. In coordination with the University, develop a progressive procurement strategy in line with the University's purchasing policies, ABOR and state statutes with industry best practices for utility P3 procurements.
- 4.1.1.7. Take lead on the preparation of the P3 technical specifications for the Procurement Documents appropriate for the agreed upon process such as an RFI or RFQ or RFP and relevant supporting documentation from existing University studies and data such as the University's <u>Climate Action Plan</u> to include with these Procurement Documents to support quality responses.
- 4.1.1.8. Identify target companies and or consortia for distribution of initial P3 Procurement Documents.

4.1.2. Phase Two

- 4.1.2.1. Assist the University's procurement in the preparation of P3 technical scope of work and provide appropriate relevant documentation from existing University's data to include with the Request for Proposal to encourage high quality bid responses.
- 4.1.2.2. Serve as the University's a committee member to evaluate responses by providing engineering, regulatory, risk, governance, and financial assessments to the University to inform final selection of partner and feasibility of modernization and decarbonization solutions.
- 4.1.2.3. Make recommendations on the best P3 options and financing structures.
- 4.1.2.4. Participate in the evaluation scoring and the University's selection of firm/s.
- 4.1.2.5. Provide decision analysis and support for the University decision makers.
- 4.1.2.6. Work with legal and any other required project advisors.
- 4.1.2.7. Assist the University to negotiate final agreement with selected P3 energy services partner including terms of coordination, reporting, monitoring and oversight

4.1.3. Phase Three

- 4.1.3.1. Post closing governance and monitoring (This is optional, and the university is not committed at this time to what the post-closing support will be necessary for the selected energy advisor)
- 4.1.3.2. Work with P3 energy services partner to implement practical plans for implementing the reporting and monitoring requirements established in the agreement.
- 4.1.3.3. Prepare summary, guides, checklists, policies and protocols for use by university staff tasked with monitoring agreement compliance and ensuring proper operational coordination between university staff and the P3 energy services partner.
- 4.1.3.4. Assist with developing job descriptions for any new or repurposed university positions tasked with coordinating and monitoring the performance of the P3 energy services partner.

- 4.1.3.5. Assist with resolving any issues that arise between the university and P3 energy services partner through the course of construction and initial implementation of the agreement once the newly constructed plants open.
- 4.1.3.6. Coordinate with university staff or a consulting engineer to provide detailed monitoring of the construction process to ensure the P3 energy services partner follows the construction plans approved by the university and properly communicates with the university when deviations from the plans are required or would provide additional benefits to the university.

4.2. Preferred Qualifications for the P3 Energy Advisor

4.2.1. Energy Decarbonization Expertise

4.2.2. Public-Private Partnership (P3) Experience

Include the challenges associated with the P3 governance coordination, how they were resolved and any operational control and risk transfer issues and the strategies used to meet the project goals and operational needs.

4.2.3. Technical Proficiency

Describe strong technical knowledge of energy systems, especially district energy and thermal strategies such as biomass-based solutions and heat pump integration in addition to other solutions. This expertise should encompass evaluating technical and economic feasibility, integration with existing infrastructure, and forward thinking to integrate with future technological and regulatory trends.

4.2.4. Engineering and Utility Expertise

Describe background in engineering, utilities, and energy systems, enabling a comprehensive understanding of technical aspects, infrastructure compatibility, and system optimization.

4.2.5. Financial Analysis Acumen

Describe capabilities in conducting thorough and meticulous financial analyses for energy projects, including risk assessment, cost modeling, and revenue forecasting. Experience in evaluating financial feasibility for P3 opportunities is essential.

4.2.6. Market Insights

Describe adeptness in providing strategic insights into socio-political and legislative trends within the energy sector, enabling informed decision-making in alignment with the university's goals and the evolving energy landscape. Proposers to have significant experience taking advantage of financial and state incentives for clean energy, particularly provisions of the Inflation Reduction Act and other relevant legislation.

4.2.7. Procurement Strategies

Describe ability to devise and execute optimal procurement strategies, incorporating private sector participation while maximizing alignment with sustainability objectives and financial constraints.

4.2.8. Risk Management

Describe experience in identifying, evaluating, and mitigating risks associated with complex energy projects, offering innovative strategies tailored to the University's specific context.

4.2.9. Stakeholder Engagement

Describe experience with stakeholder engagement to foster community involvement, transparent communication, public support and project success.

4.2.10. Client References

Provide references from previous clients, showcasing the ability to drive impactful outcomes, adhere to timelines, and deliver exceptional results in similar energy decarbonization projects.

4.2.11. Strategic Communication

Describe proficiency in establishing transparent communication mechanisms and reporting structures, ensuring continuous updates on project progress, findings, and recommendations.

4.2.12. Holistic Approach

Provide a clear methodology that integrates technical assessment, financial feasibility, and market analysis into a cohesive strategy for the University's decarbonization objectives.

4.2.13. Alignment with the University's Vision

Describe how Proposer will support University's sustainability goals and commitment to achieving transformative outcomes, reflecting in the proposed approach and project team.

4.2.14. Excellence

Demonstrate a team of experts with relevant experience in executing transformative energy initiatives, highlighting their roles, expertise, and ability to collaborate effectively.

4.2.15. Innovative Approach

Describe Proposer's innovative thinking in approaching technical assessment, financial modeling, risk mitigation, and stakeholder engagement, tailored to the University's unique context.

4.3. Project Timeline and Deliverables

- 4.3.1. Provide a detailed project timeline and pricing for each phase of the scope of work. Proposers may include additional tasks they believe necessary for each phase of the scope of work. The timeline should encompass key milestones, deliverables, and critical decision points that showcasing your strategic planning and project management capabilities. 4.5. Proposal Submission

- 4.5.1. Provide a comprehensive Proposal that addresses all aspects, demonstrating attention to detail and a thorough understanding of the University's requirements outlined in this RFP.
- 4.5.2. Comprehensive Proposal to include the following:
 - 4.5.2.1. A comprehensive overview of the advisory firm's track record, highlighting successful engagements in energy decarbonization projects and renewable energy integration.
 - 4.5.2.2. Proposer's qualifications and expertise.
 - 4.5.2.3. Approach to conducting a holistic technical assessment, integrating financial feasibility and market analysis into your strategy.
 - 4.5.2.4. Key members of your project team, emphasizing their expertise and relevant experience in executing similar transformative initiatives. Include your primary team and alternates to your team should a member depart during the process. Provide the day-to-day contact.

4.5.2.4.1. Indicate of your firm will utilize any subcontracted firms. If so, provide their roles

4.6. Warranties.

4.6.1. Each Proposal shall state the warranties to be offered by Proposer.

4.7. Additional Services.

Proposer may offer services not specifically requested in this RFP, including associated costs. The University shall determine, in its sole discretion, which additional goods/service options are the most beneficial from both a cost and service standpoint, and may further negotiate these options to include or omit, at any time throughout the Contract or any renewal term, dependent on the needs of the University.

4.7.1.1. Any pricing information regarding the additional services should be listed separately in Exhibit 2, Pricing Proposal.

4.8. Quality Assurance Plan.

Proposals shall provide a quality assurance plan that details the methods by which the Proposer guarantees performance.

4.9. Sustainability.

The University is committed to buying products with recycled content or environmentally sustainable alternatives. Identify all environmentally sustainable features and supply all relevant specifications of offered products. Include in the Proposal, information regarding Proposer's overall sustainable efforts.

5. PRICING AND PAYMENT

- 5.1. Proposer shall submit a detailed cost proposal in the format found in Exhibit 2 to include all aspects of providing the scope of work associated with this RFP.
- 5.2. Any pricing and/or revenue offerings in a Proposal may be considered a final offer by the University, whether stated as amounts or percentages, and/or whether or not offered on an all-or-none basis, unless otherwise specified in the Proposal. The University may accept or reject in part or entirely a Proposal's pricing and/or revenue offerings, unless otherwise specified in the Proposal. A Proposal's pricing and/or revenue offering may not be modified after Opening unless the University, at its sole discretion, permits such modification. The University may reject any Proposal in which the pricing and/or revenue offering does not conform to the prescribed manner and method in this RFP
- 5.3. Method of Payment & Discount for Early Payment. The University's preferred method of payment is via credit card. Each Proposal shall indicate whether Proposer will:
 - 1) Accept payment via credit card at the time of purchase without assessing credit card fees;
 - 2) Offer an early payment discount (and describe the offering);
 - 3) Offer an early payment discount if paid via credit card;
 - 4) Accept payment via a Single Use Account when the invoice is processed through Accounts Payable. A Single Use Account is a card-based payment solution that acts like a check by providing a 16-digit virtual account number for each payment.

- 6. **QUALIFICATIONS/FINANCIAL STATEMENTS** The University is soliciting Proposals from Persons which are in the business of providing services as listed in this RFP. Failure to include any requested information may be grounds for rejection of the Proposal.

Proposals shall present a corporate history/management summary and evidence that the Proposer and/or its officers have been engaged for a minimum of three (3) years in providing similar products and services as described herein. Proposer may also describe Proposer's growth for the past three (3).
 - 6.1.1. Describe any restructuring, mergers, and/or downsizing that has occurred over the past three (3) years or is anticipated in the next two (2) years.
 - 6.1.2. Detail Proposer's experience with similar/like projects.

6.2. Disputes/Litigation.

- 6.2.2. Describe litigation disputes for the past 5 years related to similar projects or Proposer's ability to perform.

6.3. Proposer References.

- 6.3.1. Provide, at minimum, three (3) references, not including the University, identifying firms with requirements similar to those of the University. Provide the name of the firm, contact person, email and the telephone number.
- 6.3.2. The University may, but is not required to, contact the provided references and/or additional references not provided by Proposer. The University may give preference to those references that are most similar to the University.
- 6.3.3. Provide references from previous clients, showcasing Proposers ability to drive impactful outcomes and commitment to client satisfaction.

7. RFP PROCESS

7.1. Intent / Right to Terminate and Recommence RFP Process. The University intends to enter into a Contract with one or more Proposers whose Proposal(s) are considered to be in the best interests of the University. However, the University may terminate this RFP process at any time up to notice of Award, without prior notice, and without liability of any kind or amount. Further, the University reserves the right to commence one or more subsequent RFP processes seeking the same or similar products or services covered hereunder.

7.2. Communications Regarding the RFP.

- 7.2.1. No department, school, or office at the University has the authority to solicit or receive official Proposals other than Contracts, Purchasing and Risk Management. All solicitations are performed under the supervision of the Chief Procurement Officer and in accordance with University policies and procedures.
- 7.2.2. Any and all questions regarding this RFP shall be directed to the Purchasing unit of Contracts, Purchasing and Risk Management and to no other office or individual at the University. Any Proposer who improperly attempts to communicate with unauthorized University personnel regarding the RFP may face disqualification at the discretion of the University.
- 7.2.3. All formal inquiries or requests for significant or material clarification or interpretation, or notification to the University of errors or omissions relating to this RFP must be in writing, and directed by email to: Debra.Cisneros@nau.edu All formal inquiries must be submitted at least ten (10) calendar days before the time and date set for closing this RFP. Failure to submit inquiries by this deadline may result in the inquiry not being answered. Failure to receive addenda shall not constitute a basis for claim, protest, or reissuance of the RFP.
- 7.2.4. The University may answer informal questions orally. The University makes no warranty of any kind as to the correctness of any oral answers and uses this process solely to quickly provide minor clarifications. Oral statements or instructions shall not constitute an addendum to this RFP. Proposer shall not be entitled to rely on any verbal response from the University.

NOW, THEREFORE, in consideration of the above premises, the parties hereto agree as follows:
Contract. Contractor agrees to provide ("Services") to include but no limited in accordance with the terms and conditions herein and Exhibit A, attached hereto and incorporated herein by reference.
1. <u>Term.</u>
a. The Contract shall commence on, for an initial one (1) year period with the option to renew for four (4) additional one (1) year periods for a total term not to exceed five (5) years.
b. The University may terminate the Contract, in whole or in part, including pursuing all remedies afforded by law or in equity with or without cause, upon thirty (30) days written notice to Contractor. Subject to the provision of any Transition Services (as defined below), upon termination, Contractor will refund to the University all prepaid amounts for Services not delivered or performed. If the Contract is terminated pursuant to this section, subject to the provision of any Transition Services, the University will pay Contractor, as full compensation under the Contract (1) the portion of Services delivered or performed and accepted prior to the effective date of termination based on the unit prices in the Contract, or, if no unit prices are provided, the pro-rate amount of the total order price based on the amount delivered or performed; and (2) a reasonable amount, not otherwise recoverable from other sources by Contractor, and as approved by the University, with respect to the undelivered, unperformed, or unacceptable portion of the Services In no event will compensation paid previously under the Contract together with compensation paid under this section exceed the total purchase order or Contract price.

- d. The University shall have the right to terminate this Contract at any time in the event the Contractor files a petition in bankruptcy, or is adjudicated bankrupt; or if a petition in bankruptcy is filed against the Contractor and not discharged within thirty (30) days; or if the Contractor becomes insolvent or makes an assignment for the benefit of its creditors or an arrangement pursuant to any bankruptcy law; or if a receiver is appointed for the Contractor or its business.
- e. Upon termination of the Contract or termination of any Services (regardless of the reason for termination), the parties will work in good faith to transition the terminated Services to the University or its designee(s), with minimum interruption to the University's business. At the University's option, Contractor will continue to provide Services and will provide transition support at rates consistent with the terms of the Contract for a period of no longer than one-hundred and eighty (180) days following the termination date (the Transition Period). Contractor will provide the post-termination Services (the Transition Services) at least at the same levels of quality and timeliness of performance as Services were provided prior to termination, in a professional manner, with high quality, and in accordance with industry standards. The parties may, by written agreement, modify the Transition Services to be provided and the length of the Transition Period.
- f. In accordance with ARS §35-154 and §41-2546, if the University's performance under the Contract depends on the appropriation of funds by the Arizona Legislature, and if the Legislature fails to appropriate the funds necessary for performance, then the University may provide written notice of this to Contractor and cancel the Contract without further obligation of the University. Appropriation is a legislative act and is beyond the control of the University.
- 2. <u>Survival.</u> All provisions of the Contract that anticipate performance after the termination of the Contract, and all provisions necessary or appropriate to interpret and enforce such provisions, will survive termination of the Contract.
- 3. Settlement Method and Terms. Payment will be subject to the provisions of Title 35 of the Arizona Revised Statutes ("ARS"), as amended from time to time, relating to time and manner of submission of claims. The University's obligation will be payable only and solely from funds appropriated for the purpose of the Contract. After delivery and acceptance of the Services, Contractor will submit an acceptable invoice to the University. Invoices must be itemized, reference the appropriate University purchase order number, and include sufficient detail to document the invoiced amount. The University will pay Contractor for the Services delivered and accepted net 30 days after receipt by the University of an invoice meeting the requirements of this section. Invoices will be electronically delivered to the University's Accounts Payable department by email to Accounts Payable@nau.edu.
- 4. <u>Independent Contractor.</u> Contractor is an independent contractor. Neither the University nor Contractor may bind the other. None of the Contractor Parties will be employees, agents, partners, or joint venturers of the University. None of the Contractor Parties will be eligible for any benefits from the University, including worker's compensation coverage. Contractor is responsible to the University for compliance with the Contract by the Contractor, or any of its owners, officers, directors, members, managers, agents, employees, contractors or subcontractors

at all tiers (together with Contractor, the Contractor Parties). Contractor will determine Contractor's hours of work, and will provide all tools, equipment, and supplies Contractor determines to be necessary to deliver and perform the Services. Contractor will maintain all business registrations and licenses required to deliver and perform the Services. Contractor is using its own knowledge, skill, and technical know-how in the delivery and performance of the Services and is not being supervised by the University.

- 5. <u>Conduct and Control of Services.</u> The conduct and control of the Services under this Contract lies solely with Contractor, and the University is interested only in final results to be achieved. The University shall be permitted to retain other contractors performing the same of similar tasks, and the Contractor shall be permitted to provide services to other parties, consistent with the Contractor's obligations to complete the Services undertaken pursuant to the terms of this Contract.
- **6. Work Product.** All reports, drawings and other work products in any medium produced by Contractor as a part of the Services rendered under this Contract shall be provided to and be the sole property of the University. Contractor shall not release this work product or other information obtained or produced pursuant to this Contract without the prior written consent of the University.
- 7. <u>Conflict of Interest.</u> The parties agree that this Contract may be canceled for conflict of interest in accordance with A.R.S. § 38-511.
- **8.** <u>Dispute Resolution.</u> If a dispute arises under the Contract, the parties will exhaust all applicable administrative remedies provided for under Arizona Board of Regents Policy 3-809.
- **Arbitration.** The parties agree to arbitrate disputes filed in Arizona Superior Court that are subject to mandatory arbitration pursuant to ARS § 12-133.

10. Indemnification.

a. Contractor shall indemnify, defend and hold harmless, the University, the State of Arizona, and the Arizona Board of Regents and their employees and agents from all losses, damages, claims, liabilities, costs and expenses (including, without limitation, costs and expenses of litigation and alternative dispute resolution, reasonable attorneys' and paralegals' fees, worker's compensation claims, unemployment compensation claims and unemployment disability claims) arising from any actual or alleged damage to property, injury to any person, or death of any person to the extent that such damage, injury or death arises from any actual or alleged act or omission (including, without limitation, negligence and willful misconduct) of Contractor or any of Contractor's employees, agents or representatives in connection with or incident to performance of this Contract, provided, however, that this indemnification shall not include (i) losses, damages, claims, liabilities, costs and expenses arising from professional errors or omissions of Contractor or any of Contractor's employees, agents or representatives or (ii) losses, damages, claims, liabilities, costs and expenses of the University or the Arizona Board of Regents arising from any obligation undertaken by the University or the Arizona Board of Regents in any contract entered into in connection with the Services of Contractor.

- b. Notwithstanding any expiration or termination of this Contract, this indemnification shall remain in effect indefinitely without termination as to acts and omissions actually occurring or alleged to have occurred prior to expiration of termination of this Contract.
- 11. <u>Non-Appropriation.</u> This Contract may be canceled without any further obligation on the part of the University in the event that sufficient appropriated funding is unavailable to assure full performance of its terms. Contractor shall be notified in writing of any such non-appropriation at the earliest opportunity.
- 12. <u>Inspection.</u> To the extent required by ARS § 35-214, all books, accounts, reports, files and other records relating to this Contract shall be subject at all reasonable times to inspection and audit by ABOR, the University, or the Auditor General of the State of Arizona, or their agents for five (5) years after completion of this Contract. Such records shall be produced at the University, or other location as designated by the University, upon reasonable notice to the Contractor.
- 13. Authorized Presence Compliance. As required by ARS § 41-4401, the University is prohibited from awarding a contract to any contractor or subcontractor that fails to comply with ARS § 23-214(A) (verification of employee eligibility through the e-verify program). Contractor warrants that it and its subcontractors comply fully with all applicable federal immigration laws and regulations that relate to their employees and their compliance with ARS § 23-214(A). A breach of this warranty will be a material breach of this Contract that is subject to penalties up to and including termination of this Contract. The University retains the legal right to inspect the papers of any Contractor or Contractor Party employee who works hereunder to ensure that the Contractor or Contractor Party is complying with the above warranty.
- 14. No Boycott of Goods or Services from Israel. If the Goods/Services provided under this Contract include the acquisition of services, supplies, information technology or construction with a value of at least one hundred thousand dollars (\$100,000) and Contractor is engaged in for-profit activity and has ten (10) or more full-time employees, then, to the extent required by ARS § 35-393.01, Contractor certifies it is not currently engaged in, and during the term of this Contract will not engage in, a boycott of goods or services from Israel.
- 15. No Forced Labor of Ethnic Uyghurs. To the extent required by A.R.S. § 35-394, Contractor certifies it is not currently, and during the term of this Agreement will not use: 1) the forced labor of ethnic Uyghurs in the People's Republic of China; 2) any goods or services produced by the forced labor of ethnic Uyghurs in the People's Republic of China; or 3) any contractors, subcontractors or suppliers that use the forced labor or any goods or services produced by the forced labor of the ethnic Uyghurs in the People's Republic of China. If Contractor becomes aware during the term of the agreement that it is not in compliance with this written certification, it shall notify University within five (5) business days of becoming aware of the noncompliance.
- 16. <u>Insurance Requirements.</u> Without limiting any liability of or any other obligation of Contractor, Contractor shall procure and maintain (and cause its subcontractors to procure and maintain), until all of their obligations have been discharged or satisfied, including any warranty periods under this Contract, insurance against claims that may arise from or in connection with the performance of work hereunder by Contractor, its agents, representatives, employees or

subcontractors, the minimum insurance coverages listed below, unless otherwise agreed to in writing. Contractor's insurance shall be placed with companies licensed in the State of Arizona or hold approved non-admitted status on the Arizona Department of Insurance List of Qualified Authorized Insurers. Insurers shall have an "A.M. Best" rating of not less than A- VII. The University in no way warrants that the above required minimum insurer rating is sufficient to protect the Contractor from potential insurance insolvency. Self-insurance may be accepted in lieu of or in combination with the insurance coverage requested.

a. **Commercial General Liability** of \$1,000,000 minimum limit for each occurrence and \$2,000,000 general aggregate, to include coverage for bodily injury, property damage, personal and advertising injury, and broad form contractual liability coverage.

- b. **Automobile Liability** of \$1,000,000 minimum Combined Single Limit each occurrence, to include coverage for bodily injury and property damage for any owned, hired, and/or non-owned automobiles assigned to or used in the performance of this Contract.
- c. **Workers Compensation** coverage for all employees which meets Arizona statutory benefits and Employers' Liability insurance with a minimum limit of \$1,000,000 each accident, \$1,000,000 disease each employee, and \$1,000,000 disease policy limit.

This requirement shall not apply to each Contractor or subcontractor that is exempt under ARS § 23-901 and when such Contractor or subcontractor executes the appropriate form (Sole Proprietor Waiver or Independent Contractor Agreement).

- d. If applicable, in the University's sole discretion, Professional Liability (Errors and Omissions Liability) of \$1,000,000 minimum limits for each claim (or each wrongful act) and 2,000,000 annual aggregate.
 - i. In the event that the Professional Liability insurance required by this Contract is written on a claims-made basis, Contractor warrants that any retroactive date under the policy shall precede the effective date of this Contract; and that either continuous coverage will be maintained or an extended discovery period will be exercised for a period of two (2) years beginning at the time work under this Contract is completed.
 - ii. The policy shall cover professional misconduct or lack of ordinary skill for those positions defined in the scope of work of this Contract.

- e. If applicable, in the University's sole discretion, Builder's Risk or Installation Floater (as appropriate) in an amount that represents the estimated completed value of the project.
- f. If Contractor is working with children or vulnerable adults, then coverage for Sexual Abuse and Molestation (SAM) of \$500,000 minimum limit, to include the following statement or evidence on the certificate of insurance that "Sexual Abuse/Molestation coverage is included." The limits may be included within the Commercial General Liability limit, Professional Liability limit, provided by separate endorsement with its own limits, or provided as separate coverage.
- g. If Contractor is providing software, software or systems development or hardware, or is an internet/application service provider (e.g. web hosting), then Technology Errors and Omissions insurance with minimum limits of \$2,000,000 each claim (or each wrongful act) and \$2,000,000 annual aggregate.
 - i. Such insurance shall cover any and all errors, omissions, or negligent acts in the delivery of products, services, and/or licensed programs under this Contract.
 - ii. Coverage shall include copyright infringement, infringement of trade dress, domain name, title or slogan.
 - iii. In the event that the Technology Errors and Omissions insurance required by this Contract is written on a claims-made basis, Contractor warrants that any retroactive date under the policy shall precede the effective date of this Contract; and that either continuous coverage will be maintained or an extended discovery period will be exercised for a period of two (2) years beginning at the time work under this Contract is completed.
- h. If Contractor is directly connected to the University's network, information security vendor, or internet/application service provider (e.g. web hosting), then Network Security (Cyber) and Privacy Liability with minimum limits of \$2,000,000 each claim (or wrongful act) and \$2,000,000 annual aggregate.
 - i. Such insurance shall include, but not be limited to, coverage for third party claims and losses with respect to network risks (such as data breaches, unauthorized access or use, identity theft, theft of data) and invasion of privacy regardless of the type of media involved in the loss of private information, crisis management and identity theft response costs. This should also include breach notification costs, credit remediation and credit monitoring, defense and claims expenses, regulatory defense costs plus fines and penalties, cyber extortion, computer program and electronic data restoration expenses coverage (data asset protection), network business interruption, computer fraud coverage, and funds transfer loss.

- ii. In the event that the Network Security (Cyber) and Privacy Liability required by this Contract is written on a claims-made basis, Contractor warrants that any retroactive date under the policy shall precede the effective date of this Contract; and that either continuous coverage will be maintained or an extended discovery period will be exercised for a period of two (2) years beginning at the time work under this Contract is completed.
- i. If Contractor is providing content such as but not limited to software code, text, data, images, and other media-related services including web design and/or marketing firms, then Media Liability insurance with minimum limits of \$2,000,000 each claim (or each wrongful act) and \$2,000,000 annual aggregate.
 - i. Such insurance shall cover any and all errors and omissions or negligent acts in the production of content, including but not limited to plagiarism, defamation, libel, slander, false advertising, invasion of privacy, and infringement of copyright, title, slogan, trademark, service mark and trade dress.
 - ii. In the event that the Media Liability insurance required by this Contract is written on a claims-made basis, Contractor warrants that any retroactive date under the policy shall precede the effective date of this Contract; and that either continuous coverage will be maintained or an extended discovery period will be exercised for a period of two (2) years beginning at the time work under this Contract is completed.
- Policies for Commercial General Liability and Automobile Liability shall be endorsed to include the State of Arizona, and its departments, agencies, boards, commissions, universities, officers, officials, agents and employees as additional insureds with respect to liability arising out of the activities performed by or on behalf of Contractor. Such additional insured shall be covered to the full limits of liability purchased by the Contractor, even if those limits are in excess of those required by the Agreement. Policies for Commercial General Liability, Automobile Liability, and Workers Compensation shall contain a waiver of subrogation endorsement in favor of the State of Arizona, and its departments, agencies, boards, commissions, universities, officers, officials, agents, and employees for losses arising from work performed by or on behalf of Contractor. Such coverage shall stipulate that the insurance afforded the Contractor shall be primary and that any insurance carried by Northern Arizona University, the Arizona Board of Regents, or the State of Arizona shall be excess and not contributory insurance, as provided by Arizona Revised Statutes §41-621(E). With the exception of ten (10) days' notice of cancellation for non-payment of premium, Contractor's insurance shall not be permitted to expire, be suspended, be cancelled, or be materially changed for any reason without thirty (30) days prior written notice to the University. Contractor will furnish the University with valid certificate(s) of insurance required by the Contract and coverage must be in effect at or prior to commencement of work under the Contract and remain in effect for the term of the Contract. The University's project or purchase order number and project description will be noted on each certificate of insurance. The Certificate Holder shall be listed as "State of Arizona, Arizona Board of Regents and Northern Arizona University". Failure on the part of the

Contractor to maintain these requirements or provide evidence of renewal, shall constitute a material breach of the Contract upon which the University may immediately terminate the Contract, or, in the University's sole discretion, procure or renew such insurance and pay any and all premiums in connection therewith, and all monies so paid by the University shall be repaid by Contractor to the University upon demand, or University may offset the cost of the premiums against any monies due to Contractor. Costs for coverage broader than those required or for limits in excess of those required shall not be charged to the University. The University reserves the right to request and receive proof of insurance and/or certified copies of any or all of the above policies and/or endorsements at any time throughout the term of the Contract. Neither Contractor's failure to provide, nor the University's failure to obtain proof of compliance shall act as a waiver of any term of this section. Contractor's certificate(s) of insurance may include all subcontractors as insureds under its policies as require by the Contract, or Contractor will furnish to the University upon request, copies of valid certificates and endorsements for each subcontractor. Coverages for subcontractors will be subject to the minimum requirements identified above.

- 17. Governing Law and Venue. The Contract will be governed exclusively by the laws of the State of Arizona without regard to any conflicts of laws principles. The University's obligations hereunder are subject to the regulations/policies of the Arizona Board of Regents. Any proceeding arising out of or relating to the Contract will be conducted in Coconino County, Arizona. Each party consents to such jurisdiction and waives any objection it may now or hereafter have to venue or to convenience of forum.
- **18.** Arizona Public Records Laws. The University, as a public institution, is subject to ARS §§ 39-121to 39-127 regarding public records. Any provision regarding confidentiality is limited to the extent necessary to comply with Arizona law.
- 19. <u>Interpretation-Parol Evidence</u>. The Contract is intended by the parties as a final expression of their agreement and is intended to be a complete and exclusive statement of the terms of said Contract. No course of prior dealings between the parties and no usage of the trade will be relevant to supplement or explain any term used in the Contract. Acceptance or acquiescence in a course of performance rendered under the Contract will not be relevant to determine the meaning of the Contract even though the accepting or acquiescing party has knowledge of the nature of the performance and opportunity for objection. Whenever a term defined by the Uniform Commercial Code is used in the Contract, the definition contained in the Code, as adopted by the state of Arizona, will control.
- **20.** Privacy; Educational Records. Student educational records are protected by the U.S. Family Educational Rights and Privacy Act, 20 U.S.C. §1232g and its implementing regulations ("FERPA"). Contractor will not require any University students or employees to waive any privacy rights (including FERPA or the European Union's General Data Protection Regulation ("GDPR")) as a condition for receipt of any educational services, and any attempt to do so will be void. Contractor will comply with FERPA and will not access or make any disclosures of student educational records to third parties without prior notice to and consent from the University or as otherwise provided by law. If the Contract contains a scope of work or other provision that requires or permits Contractor to access or release any student records, then, for purposes of the Contract

only, the University designates Contractor as a "school official" for the University under FERPA, as that term is used in FERPA. In addition, any access or disclosures of student educational records made by Contractor or any Contractor Parties must comply with the University's definition of legitimate educational purpose which can be found here. If Contractor violates the terms of this section, Contractor will immediately provide notice of the violation to the University.

- 21. Health Insurance Portability and Accountability Act. Contractor shall abide by all laws and regulations that protect the privacy of healthcare information to which Contractor obtains access under this Contract. Contractor and the University acknowledge that certain portions of the Administrative Simplification section of the Health Insurance Portability and Accountability Act of 1996 ("HIPAA"), as codified at 42 U.S.C. § 1320d through d-8, and the federal privacy regulations as contained in 45 CFR Part 164 may apply to Contractor and the University, and their relationships and operation under this Contract. If necessary, Contractor and the University will enter into a standard Business Associate Contract, and any other required Health Insurance Portability Accountability Act agreements. To the extent the terms thereof relate to Contractor's performance under this Contract, the provisions of such Business Associate Contract shall control.
- **22.** Americans with Disabilities Act and Rehabilitation Act. To the extent appropriate, Contractor will comply with all applicable provisions of the Americans with Disabilities Act ("ADA") in a manner consistent with the Web Accessibility Initiative Web Content Accessibility 2.1AA Guidelines (WCAG), the Rehabilitation Act of 1973, and all applicable federal regulations, as amended from time to time ("ADA Laws"). All electronic and information technology and products and services to be used by University faculty/staff, students, program participants, or other University constituencies must be compliant with ADA Laws. Compliance means that a disabled person can acquire the same information, engage in the same interactions, and enjoy the same services as a nondisabled person, in an equally effective and integrated manner, with substantially equivalent ease of use.
- 23. <u>No Waiver</u>. No waiver by the University of any breach of the provisions of this Contract by the Contractor shall in any way be construed to be a waiver of any future breach or bar the University's right to insist on strict performance of the provisions of the Contract.
- **24.** <u>Modifications</u>. This Contract may be modified only by a written instrument signed by both parties or their duly authorized agents.
- **25.** Assignment. Contractor may not transfer or assign the Contract or any of Contractor's rights or obligations thereunder, either directly or indirectly, or by operation of law, without the University's prior written consent, and any attempt to the contrary will be void.
- **26.** Assignment of Anti-Trust Overcharge Claims. In actual economic practice, overcharges resulting from anti- trust violations are borne by the ultimate purchaser. Therefore, Contractor hereby assigns to the University any and all claims for such overcharges.
- **27. Prices.** All Prices will be as listed in a University purchase order as set forth in Exhibit B. Unless otherwise specified in the Contract: 1) all prices are in US Dollars; 2) prices include any cost

for shipping, and handling; and 3) prices will include any travel, labor, interest, import/export fees, and other costs associated with providing the Goods/Services.

- **28.** <u>Taxes.</u> Unless otherwise specified in the Contract, prices will include all taxes and fees, including, without limitation, sales, use, or excise taxes, import duties, value added taxes, permit fees, license fees, or similar charges (Taxes). Taxes do not include the University or Contractor income taxes or taxes related to the University's or Contractor's employees.
- **29.** Responsibility. Contractor is responsible for the negligent or willful acts or omissions of its employees and contractors when acting under Contractor's direction and supervision. In addition, Contractor is responsible to the University for compliance with the Contract by the Contractor Parties. The University recognizes an obligation to pay attorneys' fees or costs only when assessed by a court of competent jurisdiction. Notwithstanding the terms of the Contract or any other document, the University is not responsible for any actions of any third parties, including its students; and no person may bind the University unless such person is an authorized signatory as defined in the University's Purchasing Policy PUR 202-00.
- Intellectual Property Ownership. All Intellectual Property (as defined below) that **30.** Contractor or any of the Contractor Parties make, conceive, discover, develop or create, either solely or jointly with any other person or persons including the University, specifically for or at the request of the University in connection with the Contract (Contract IP), will be owned by the University. To the extent any Contract IP is not considered work made for hire for the University (or if ownership of all rights therein does not otherwise vest exclusively in the University), Contractor hereby irrevocably assigns, and will cause the Contractor Parties to so assign, without further consideration, to the University all right, title and interest in and to all Contract IP, including all copyright rights of ownership. Intellectual Property means all the University Data, as defined below, any and all inventions, designs, original works of authorship, formulas, processes, compositions, programs, databases, data, technologies, discoveries, ideas, writings, improvements, procedures, techniques, know-how, and all patent, trademark, service mark, trade secret, copyright and other intellectual property rights (and goodwill) relating to the foregoing. Contractor will make full and prompt disclosure of the Contract IP to the University. Contractor will, and will cause the Contractor Parties to, as and when requested by the University, do such acts, and sign such instruments to vest in the University the entire right, title and interest to the Contract IP, and to enable the University to prepare, file, and prosecute applications for, and to obtain patents and/or copyrights on, the Contract IP, and, at the University's expense, to cooperate with the University in the protection and/or defense of the Contract IP.
- 31. <u>Contractor's Intellectual Property.</u> Contractor will retain ownership of its pre-existing Intellectual Property, including any that may be incorporated into the Contract IP, provided that Contractor informs the University in writing before incorporating any pre-existing Intellectual Property into any Contract IP. Contractor hereby grants to the University a perpetual, irrevocable, royalty- free, worldwide right and license (with the right to sublicense), to freely use, make, have made, reproduce, disseminate, display, perform, and create derivative works based on such pre-existing Intellectual Property as may be incorporated into the Contract IP or otherwise provided to the University in the course of performing under the Contract.

32. Data Use, Ownership, and Privacy.

- a. The terms of this section apply if Contractor receives, has access to, stores, or analyzes any the University Data (as defined below). As between the parties, the University will own, or retain all of its rights in, all data and information that the University provides to Contractor, as well as all data and information managed by Contractor on behalf of the University, including all output, reports, analyses, and other materials relating to, derived from, or generated pursuant to the Contract, even if generated by Contractor, as well as all data obtained or extracted through the University's or Contractor's use of such data or information (collectively, the University Data). the University Data also includes all data and information provided directly to Contractor by the University students and employees, and includes personal data, metadata, and user content.
- b. The University Data will be the University's Intellectual Property and Contractor will treat it as the University Confidential Information (as defined below). Contractor will not use, access, disclose, or license, or provide to third parties, any the University Data, except: (i) to fulfill Contractor's obligations to the University hereunder; or (ii) as authorized in writing by the University. Without limitation, Contractor will not use any the University Data, whether or not aggregated or de-identified, for product development, marketing, profiling, benchmarking, or product demonstrations, without, in each case, the University's prior written consent. Contractor will not, directly or indirectly: (x) attempt to re-identify or de-aggregate de-identified or aggregated information; or (y) transfer de- identified and aggregated information to any third party unless that third party agrees not to attempt re-identification or de-aggregation. For the University Data to be considered de-identified, all direct and indirect personal identifiers must be removed, including names, ID numbers, dates of birth, demographic information, location information, and school information. Upon request by the University, Contractor will deliver, destroy, and/or make available to the University, any or all the University Data.
- 33. Nondisclosure and Trade Secrets. Contractor may receive (or has received) from the University and otherwise be exposed to confidential and/or proprietary information or otherwise required by law to be kept in confidence, relating to student information, personnel records, scripts, integration/interface processes with other systems, business practices, strategies, software, remote application access and other computer information licensed to the University, technologies, the University's Data, proprietary information about various business that performs work on the University's behalf, payroll and other financial information, and work product of the University's employees and agent, as well as confidential information of the University necessary to perform and/or provide the Services (collectively, the University Confidential Information). University Confidential Information may include, but is not limited to, confidential and proprietary information supplied to Contractor with the legend "the University Confidential and Proprietary," or other designations of confidentiality. As between Contractor and the University, the University Confidential Information is the sole, exclusive, and valuable property of the University. Accordingly, Contractor will not reproduce or otherwise use any of the University Confidential Information except in the performance or provision of the Services, and will not disclose any of the University Confidential Information in any form to any third party, either during or after the Term, except with the University's prior written consent. Contractor agrees to hold all University Confidential Information at all times in trust and strictest confidence for the University from and after the date of its creation or disclosure to Contractor. Contractor shall prevent the impermissible release of

University Confidential Information. Contractor shall not duplicate or disclose or otherwise reveal University Confidential Information in any manner inconsistent with this Contract. Contractor shall cause any subcontractors and other third parties hired by Contractor and working under this Contract who may have a need to access University Confidential Information, to abide by the nondisclosure provisions of this Contract.

The parties shall comply with all applicable local, state, federal, and foreign confidentiality and privacy laws and regulations, including but not limited to FERPA and HIPAA. Nothing in this Contract shall require or be construed to require either party to violate such provisions of law or subject either party to liability or render such party to breach this Contract for adhering to such provision of law. University Confidential Information may also include but is not limited to personally identifiable information, such as financial, employment, health, student information or police records. Contractor shall be liable for any damages arising from breach of any local, state, or federal confidentiality or privacy laws related to Contractor's performance under this Contract. Contractor shall indemnify and hold harmless the University from any and all claims, actions, liabilities, damages, losses arising from Services performed under this Contract.

Any violation by Contractor of any provision under this section shall constitute a material breach of this Contract, and as such the University reserves the right to terminate this Contract immediately without penalty and pursue any remedies allowed by law to prevent or remedy a breach by Contractor of the Contractor's obligations under this section to include injunctive relief without positing bond.

Upon termination of the Contract, Contractor will cease using, and will return to the University, all originals and all copies of the University Confidential Information, in all forms and media, in Contractor's possession or under Contractor's control. In addition, Contractor will not disclose or otherwise make available to the University any confidential information of Contractor or received by Contractor from any third party. Contractor will have no obligation to maintain as confidential the University Confidential Information (other than the University Data) that Contractor can show: (i) was already lawfully in the possession of or known by Contractor before receipt from the University; (ii) is or becomes generally known in the industry through no violation of the Contract or any other agreement between the parties; (iii) is lawfully received by Contractor from a third party without restriction on disclosure or use; (iv) is required to be disclosed by court order following notice to the University sufficient to allow the University to contest such order; or (v) is approved in writing by the University for release or other use by Contractor.

- **34. Background Checks.** Contractor will exclude from any direct participation in Contractor's performance under the Contract, any unqualified persons. In addition, Contractor will, at Contractor's expense, conduct reference checks and employment, education, social security number trace, National Sex Offender Registry, and criminal history record checks (collectively referred to hereafter as "Screenings") on any person(s) employed or contracted by Contractor to perform work under the Contract on any property used, owned, or leased by the University. As a result of such Screenings, Contractor shall remove any person(s) that pose or may pose a risk to the University from performing work under the Contract.
- 35. <u>Foreign Corrupt Practices Act/UK Bribery Act/ Local Anti-corruption Law Compliance.</u> Contractor warrants that it is familiar with the U.S. laws prohibiting corruption and

bribery under the U.S. Foreign Corrupt Practices Act and the United Kingdom laws prohibiting corruption and bribery under the UK Bribery Act. In connection with Contractor's work under the Contract, Contractor will not offer or provide money or anything of value to any governmental official or employee or any candidate for political office in order to influence their actions or decisions, to obtain or retain business arrangements, or to secure favorable treatment in violation of the Foreign Corrupt Practices Act, the UK Bribery Act, or any other local anti-corruption law, either directly or indirectly. Any breach of the U.S. Foreign Corrupt Practices Act, the UK Bribery Act, or other local anti-corruption law, will be a material breach of the Contract.

- **36.** Export Controls. If any of goods provided under the Services are export-controlled under the U.S. Export Administration Regulations, U.S. International Traffic in Arms Regulations, or through the sanctions and embargoes established through the Office of Foreign Assets Control (collectively, the Export Control Laws), Contractor will provide the University with written notification that identifies the export-controlled goods and such goods export classification. None of the work undertaken pursuant to the Contract will require either party to take or fail to take any action that would cause a violation of any of the Export Control Laws. The parties will cooperate to facilitate compliance with applicable requirements of the Export Control Laws.
- 37. **Business Continuity Plan.** If requested by the University, Contractor will provide to the University, within thirty (30) days after such request, a comprehensive plan for continuing the performance of its obligations during a public or institutional emergency (the Business Continuity Plan). The Business Continuity Plan, at a minimum, will address the following: 1) identification of response personnel by name; 2) key succession and performance responses in the event of sudden and significant decrease in workforce; 3) contingency plans for the Contractor to continue the performance of its obligations under the Contract, despite the emergency and 4) if Contractor will store, have access to, or otherwise process any the University Data, a data recovery plan that includes the following: identification of data recovery personnel by name, how the University Data will be recovered, recovery point and recovery time objectives, and steps to be taken to recover the University Data. If the University requires a data recovery plan, upon the University's request, Contractor will provide the University with evidence that Contractor annually tests the data recovery plan. In the event of a Public or Institutional Emergency, Contractor will implement the applicable actions set forth in the Business Continuity Plan and will make other commercially practicable efforts to mitigate the impact of the event. For clarification of intent, Contractor will not be entitled to any additional compensation or extension of time by virtue of having to implement a Business Continuity Plan, unless otherwise agreed to by the University in writing. A Public or Institutional Emergency means a natural or human made event that creates a substantial risk to the public, that causes or threatens death or injury to the general public, or that causes a significant disruption to the day-to-day business operations of the University.
- **38.** Payment Card Industry Data Security Standard. For e-commerce business and/or payment card transactions, Contractor will comply with the requirements and terms of the rules of all applicable Payment Card Industry ("PCI") associations or organizations, as amended from time to time (PCI Security Standards), and be solely responsible for security and maintaining confidentiality of payment card transactions processed by means of electronic commerce up to the point of receipt of such transactions by a qualified financial institution.

Contractor will, at all times during the Term, be in compliance with the then current standard for Payment Card Industry Data Security Standard ("PCI DSS"), Payment Application Data Security Standard ("PA-DSS") for software, and Project Identification Number ("PIN") Transaction Security ("PCI PTS") for hardware. Contractor will provide attestation of compliance to the University annually by delivering to the University current copies of the following: (i) Contractor's "Attestation of Compliance for Onsite Assessments – Service Providers;" (ii) an attestation that all University locations are being processed and secured in the same manner as those in Contractor's "PCI Report on Compliance;" and (iii) a copy of Contractor's PCI Report on Compliance cover letter. Contractor will notify the University immediately if Contractorr becomes non-compliant, and of the occurrence of any security incidents (including information disclosure incidents, network intrusions, successful virus attacks, unauthorized access or modifications, and threats and vulnerabilities).

Contractor's services must include the following:

- a. Contractor maintains its own network operating on its own dedicated infrastructure. Contractor's network includes a firewall that (i) includes access control rules that separate Contractor's PCI network from the University, and (ii) restricts any communication between Contractor's network devices and University systems.
- b. Contractor treats the University network as an untrusted network and no unencrypted cardholder data traverses or otherwise is stored on the University's network, and the University has no ability to decrypt cardholder data.
- c. All devices must be SRED (Secure Reading and Exchange of Data), EMV (Europay, MasterCard, and VISA) and PTS (PIN Transaction Security) POI (Point of Interaction) compliant.
- **Contractor Identification.** Contractor vehicles and personnel will be clearly identifiable when performing Services on University premises. Contractor's employees shall always be in uniform with visible company identification and Contractor's vehicles must be clearly identified with company name, phone number and or logo and with any applicable state license numbers.
- **40. Parking.** Contractor shall acquire and maintain, at their sole expense, all necessary parking permits required by the University. Parking permits along with regulations governing traffic and parking are available from University Transit Services (928-523-6623) located at 113 W Dupont Ave., Flagstaff, AZ 86011. Permit applications and vehicle registration may also be accessed on-line at https://in.nau.edu/university-transit-services/. Regulations shall be applicable to all employees of Contractor and will be strictly enforced. All fines incurred shall be the sole responsibility of the Contractor.
- **41.** Permits. Contractor shall acquire and maintain all necessary permits and licenses and shall adhere strictly to all Federal, State, County, or City laws, codes, regulations, and ordinances as applicable.
- **42.** <u>Hazard Inspection.</u> University buildings have the potential to house hazards including, but not limited to hazardous building materials, chemical, biological, or physical hazards, or conditions which may become hazardous based on specific work scope or practices. Prior to commencement of any Services Contractor will review, sign, and return a University hazard inspection and

communication form. Requests for inspection may be placed by any University employee or by the Contractor at https://in.nau.edu/facility-services/asbestos-lead-and-pcbs/, or by contacting the EH&S Material Safety Office at (928) 523-6435.

- 43. Non-Discrimination. The parties will comply with all applicable laws, rules, regulations, and executive orders governing equal employment opportunity, immigration, nondiscrimination, including the Americans with Disabilities Act, and affirmative action. If applicable, the parties will abide by the requirements of 41 CFR §§ 60- 1.4(a), 60-300.5(a) and 60-741.5(a). These regulations prohibit discrimination against qualified individuals based on their status as protected veterans or individuals with disabilities and prohibit discrimination against all individuals based on their race, color, religion, sex or national origin. Moreover, these regulations require that covered prime contractors and subcontractors take affirmative action to employ and advance in employment individuals without regard to race, color, religion, sex, national origin, protected veteran status or disability.
- **44. Data Protection.** Contractor will ensure that all Services undertaken pursuant to the Contract are performed in compliance with applicable privacy and data protection laws, rules, and regulations. In addition, Contractor is responsible to the University for compliance with the Contract by all Contractor Parties. If Contractor will serve as a Processor of the University Data that includes Personal Data of Data Subjects in the European Union, Contractor will cooperate with the University to comply with the GDPR with respect to such Personal Data and Data Subjects. This includes ensuring that all Data Subjects have signed appropriate Consents and signing and complying with all documents and agreements reasonably requested by the University, including any data processing agreements. All capitalized terms in this section not otherwise defined in the Contract are defined in the GDPR.
- **45. Small Business.** If subcontracting (Tier 2 and higher) is necessary, Contractor will make commercially reasonable efforts to use Small Business ("SB") and Small Diverse Business ("SDB") in the performance of the Services. The University may request a report at each annual anniversary date and at the completion of the Contract indicating the extent of SB and SDB participation.
- 46. Third Party Arrangements. From time to time, the University may enter into arrangements with third parties that may require Contractor to work cooperatively with and/or connect and use infrastructure with third parties. On a case-by-case basis, the University and Contractor will work cooperatively, timely, and in good faith to take such actions as may be necessary or appropriate to give effect to the University's third-party agreements. Contractor will not be bound to terms and conditions of a third party that are different from this Contract unless expressly agreed in writing. If the third party terms and conditions conflict with this Contract's terms, impact Contractor's ability to meet service level agreements of this Contract, or may cause Contractor to incur additional costs, then the parties will enter into good faith negotiations for an amendment to this Contract prior to Contractor agreeing to comply with the third party terms and conditions.
- **Gratuities.** Contractor will not give or offer any gratuities, in the form of entertainment, gifts or otherwise, or use an agent or representative of Contractor to give or offer a gratuity, to any officer or employee of the State of Arizona with a view toward securing an agreement or securing favorable treatment with respect to the awarding or amending, or the making of any determinations

with respect to the performing of such Contract. If the University determines that the Contractor has violated this section, the University may, by written notice to Contractor, cancel the Contract. If the Contract is canceled by the University pursuant to this section, the University will be entitled, in addition to any other rights and remedies, to recover or withhold the amount of the costs incurred by Contractor in providing gratuities.

- **48.** <u>Liens.</u> All goods delivered and labor performed under this Contract shall be free of all liens and, if the University requests, a formal release of all liens shall be delivered to the University.
- **49. No Replacement of Defective Tender**. Every tender of goods shall fully comply with all provisions of this Contract as to time of delivery, quantity, quality, and the like. If a tender is made which does not fully conform, this shall constitute a breach and Contractor shall not have the right to substitute a conforming tender.
- 50. <u>Title and Risk of Loss</u>. The title and risk of loss of the goods shall not pass to the University until the University actually receives the goods at the point(s) of delivery. Prices shall be F.O.B. Destination. Contractor shall retain title and control of all goods until they are delivered, received and the Contract of coverage has been completed. All risk of transportation and all related charges shall be the responsibility of the Contractor. The Contractor shall file all claims for visible and concealed damage. the University shall notify the Contractor promptly of any damaged goods and shall assist the Contractor in arranging for inspection. Notice of rejection may be made to the Contractor at any time within one month after delivery has been made. When supported by a written statement from the University, the Contractor shall not dispute its claims of damage.
- 51. <u>Inspection</u>. Contractor will supply the Services to the University exactly as specified in the Contract and applicable purchase order. The Services will meet the highest and best industry practices. The University will have the right to inspect any Services prior to and a reasonable amount of time after delivery. If the University determines that any Services are incomplete, defective, or not in compliance with the specifications or other requirements of the Contract, the University may reject such Services in whole or in part.
- Warranties. In addition to any implied warranties, Contractor warrants to the University **52.** that: 1) the Services will be free from any defects in design, workmanship, materials, or labor; 2) all of the Services will be performed in a professional and workmanlike manner and in conformity with highest and best industry standards by persons reasonably suited by skill, training and experience for the type of services they are assigned to perform; 3) Contractor will comply, and will be responsible for ensuring Contractor Parties comply with all applicable laws, rules, and regulations, including any policies of ABOR and the University, in the performance of the Contract; 4) Contractor owns or has sufficient rights in the Services that they do not infringe upon or violate any intellectual property of any third parties, and are free and clear of any liens or encumbrances; 5) if any data, code, or software developed or delivered by Contractor to the University will not contain any viruses, worms, Trojan Horses, or other disabling devices or code; 6) the prices of Services in the Contract are the lowest prices at which these or similar goods or services are sold by the Contractor to similar customers in similar quantities. In the event of any price reduction between execution of the Contract and delivery of the Services, the University shall be entitled to such reduction, and 8) all Services delivered by Contractor will conform to the

specifications, drawings, and descriptions set forth in the Contract and applicable purchase order, and to any samples furnished by Contractor. In the event of a conflict among the specifications, drawings, samples, and description, the specifications will govern.

- 53. Sales and Use Tax. The Contractor shall comply with and require all Contractor Parties to comply with all the provisions of the applicable state and sales excise tax law and compensation use tax law and all amendments to same. The Contractor further agrees to indemnify and save harmless the University, of and from any and all claims and demands made against it by virtue of the failure of the Contractor or any Contractor Party to comply with the provisions of any or all said laws in amendments. the University is not exempt from state sales excise tax and compensation use tax.
- **Changes.** Within the limits allowed by law, Contractor agrees that the University may order additional services, or make changes by altering, adding to, or deducting from the proposed Services, the Contract sum being adjusted accordingly, and Contractor shall enter into a modification of the Contract to reflect said changes.
- 55. Price Adjustment. Price changes shall only be considered at the end of one Contract period and the beginning of another. Price change requests shall be supported by evidence of increased costs to the Contractor. The University shall not approve price increases that shall merely increase the gross profitability of the Contractor at the expense of the University. Price change requests shall be a factor in the Contract extension review process. The University shall determine whether the requested price increase or an alternate option shall be in the best interest of the University.
- 56. Service Marks and Trademarks. For purposes of this provision, the phrase "the University Mark" means any trade name, trademark, service mark, logo, domain name, and any other distinctive brand feature owned or used by the University. Contractor agrees to comply with the University's trademark licensing program concerning any use or proposed use by Contractor of any of the University Mark on goods, in relation to Services, and in connection with advertisements or promotion of Contractor or its business. Except as expressly authorized in this Contract, Contractor is not permitted to use any the University Mark without prior written approval of the University. Prior to any use of any University Mark by Contractor or its affiliates or successors or assigns, Contractor will comply with the University's Licensing Policy http://nau.edu/licensing.
- **57.** Advertising, Publicity, Names and Marks. Contractor will not do any of the following, without, in each case, obtaining University prior written consent from its Marketing Department: (i) use any names, service marks, trademarks, trade names, logos, or other identifying names, domain names, or identifying marks of the University ("NAU Marks"), including online, advertising, or promotional purposes; (ii) issue a press release or public statement regarding the Contract; or (iii) represent or imply any University endorsement or support of any product or service in any public or private communication. Any permitted use of NAU Marks must comply with University requirements, including using the ® indication of a registered mark. Prior to any use of an NAU Mark by Contractor or its affiliates or successors or assigns, the Contractor will comply with the University's Licensing Policy http://nau.edu/licensing.

- **58.** <u>Weapons, Explosives, Pyrotechnics, and Fireworks.</u> Contractor acknowledges awareness of and shall comply with the University's <u>Weapons on Campus</u> policy and <u>Fire Safety</u> policy.
- 59. <u>Tobacco Free.</u> The University recognizes that tobacco use is a public health hazard and is dedicated to providing a healthy, comfortable and productive living, learning and working environment. Use of all tobacco products, including those not approved by the FDA for cessation is prohibited on the University property, facilities, grounds, parking structures, the University-owned vehicles and structures owned or leased by the University. This includes, but is not limited to, the use of cigarettes, e-cigarettes, hookah, e-hookah, chew, dip, snuff, cigars, pipes, vaporizers, etc. For additional information, go to http://nau.edu/Tobacco-Free/Policy/.
- **60.** Essence of Time. Time shall be of the essence as to matters related to this Contract.
- 61. <u>COVID-19 Pandemic.</u> When providing services on University owned or leased property, Contractor shall and shall cause its subcontractors to abide by the CDC guidelines for COVID-19 safety and ensure 1) face masks or cloth face coverings are worn at all times, 2) health screenings are conducted daily for all Contractor and subcontractor employees, 3) ill employees are not assigned to provide services and 4) the University's <u>Risk Management</u> department is notified within 24 hours, if an employee reports i) being tested for COVID-19 or ii) testing positive for COVID-19 and for cases follow all CDC guidance for quarantine or isolation. Do not provide personally identifiable information of the employee in the notification, an official representative will follow-up if needed.
- **62. Force Majeure.** Neither party will be held responsible for any losses resulting if the fulfillment of any terms or provisions of this Contract are delayed or prevented by any cause not within the control of the party whose performance is interfered with, and which by the exercise of reasonable diligence, the party is unable to prevent ("force majeure event"), including but not limited to acts of God, war, civil disturbance, terrorism, disaster, fire, earthquake, hurricanes, known or suspected threats of illness, epidemics, pandemics, or government regulations. The party impacted by the force majeure will take commercially practicable actions to mitigate the impact of the force majeure. This Contract may be terminated without further obligation or penalty, including cancellation fees or liquidated damages, of either party upon written notice from the affected party to the other party of such force majeure event.
- **Campus Deliveries and Access.** Contractor will familiarize itself with University parking, campus delivery options, and loading zones. Not all campus buildings are directly accessible and some require Contract to unload at lots or loading areas that may not be adjacent to the delivery or work location. As a result, Contractor must then transport Goods by using electric style golf carts, dolly, or other manual device across pedestrian pathways. For details about parking permits, Contractor permits, and loading zones contact University Parking and Shuttle Services at (928) 523-6623.
- **64. No Third-Party Beneficiaries.** No person or entity, whether or not mentioned or referred to in this Contract, other than the University and Contractor and each party's permitted successors

and assigns, shall be considered to be a third-party beneficiary of or entitled to assert any rights under this Contract.

- **65.** NAU Safe App. The University highly recommends Contractor and its invitees download the NAU Safe App from the Apple App Store or Google Play to receive notifications and alerts of emergencies while on campus. Additional details regarding the NAU Safe App, including specific instructions for Vendors, Contractors, Campus and Conferences, can be found at: https://in.nau.edu/its/nausafe/.
- 66. Jeanna Clery Act. If applicable, any person designated by Contractor or the University as a "Campus Security Authority" pursuant to the Jeanne Clery Act, 20 U.S.C. § 1092(f), who receives a report of a crime having taken place at any location that is owned, leased or controlled by the University or public property within the campus or immediately adjacent to and accessible from the campus is required to immediately forward the report to the University's Police Department. Should the University or Contractor contract with a security company or employ Campus Security Authorities, these requirements must be added to the applicable standard operating procedures of the University, Contractor, and/or the contracted security company and must be provided to all Campus Security Authorities, including the contracted security company's officers and supervisors who work on site on the University's owned, leased, or controlled properties.
- 67. Compliance from Contractor Parties. Contractor shall be responsible for notifying and ensuring that all persons or entities who are employees, officers, subcontractors, consultants, agents, guests, invitees, or licensees of Contractor are fully aware of the laws, policies, rules, regulations, and obligations under this Contract. Contractor shall take all reasonable steps to ensure compliance from all Contractor Parties. Contractor acknowledges should Contractor Parties violate any laws, policies, rules, regulations, and/or obligations under this Contract, it would constitute a breach of this Contract. Contractor agrees that in event of a breach of this Contract under this clause, the University may in its sole discretion impose additional fees or fines on the Contractor, request Contractor Parties to immediately vacate the premises, and/or terminate this Contract in its entirety.
- **Relationship of the Parties.** For all purposes under this Contract, Contractor shall be an independent contractor, and not an officer or employee of University. This Contract does not create a partnership, joint venture, or agency relationship between the parties of any kind or nature. No party shall have any right, power, or authority under this Contract to act as a legal representative of the other party, and no party shall have any power to obligate or bind the other party or to make representations, expressed or implied, on behalf of or in the name of the other party in any manner or for any purpose whatsoever. Each party acknowledges that the relationship of the parties hereunder is non-exclusive.
- **Written Reports.** If applicable, Contractor shall provide such interim written reports concerning the performance of Services and research under this Contract as the University may request in writing, and upon expiration or other termination of this Contract shall at the request of the University provide a written report to the University setting forth the results of the Services performed hereunder.

- **70. Prohibitions.** Contractor hereby acknowledges awareness of the laws and regulations prohibiting the use and/or possession of alcoholic beverages, narcotics, and illegal drugs on the campus of Northern Arizona University.
- 71. <u>Gramm-Leach-Bliley Act ("GLBA").</u> If Contractor is engaged as a "Service Provider" under GLBA, then Contractor agrees to protect customer financial information in accordance with the GLBA.
- **172.** Information Security. The terms of this section apply if: 1) University is purchasing or leasing software, or processing a software renewal; 2) Contractor is creating any code for the University; 3) Contractor receives, stores, or analyzes University Data (including if the data is not online); OR 4) Contractor is hosting, or managing by infrastructure outside of the University, including any cloud-based systems, University Data.

All systems containing University Data must be designed, managed, and operated in accordance with information security best practices and in compliance with all applicable laws, rules, and regulations. To diminish information security threats, Contractor will (either directly or through its third party service providers) meet the following requirements:

- a. Access Control. Control access to University's resources, including sensitive University Data, limiting access to legitimate business need based on an individual's job-related assignment. Contractor will, or will cause the system administrator to, approve and track access to ensure proper usage and accountability, and Contractor will make such information available to University for review, upon University's request.
- b. Incident Reporting. Report information security incidents immediately to the University (including those that involve information disclosure incidents, unauthorized disclosure of University Data, network intrusions, successful virus attacks, unauthorized access or modifications, and threats and vulnerabilities).
- c. Off-Shore. Direct Services that may involve access to secure or sensitive University Data or personal client data or development or modification of software for the University, will be performed within the borders of the United States. Unless stated otherwise in the Contract, this requirement does not apply to indirect or "overhead" services, redundant back-up services or services that are incidental to the performance of the Contract. This provision applies to work performed by subcontractors at all tiers and to all University Data.
- d. Patch Management. Carry out updates and patch management for all systems and devices in a timely manner and to the satisfaction of the University. Updates and patch management must be deployed using an auditable process that can be reviewed by the University upon the University's request.

- e. Encryption. All systems and devices that store, process or transmit sensitive University Data must use an industry standard encryption protocol for data in transit and at rest.
- f. Notifications. Notify the University immediately if Contractor receives any kind of subpoena for or involving University Data, if any third party requests University Data, or if Contractor has a change in the location or transmission of University Data. All notifications to University required in this Information Security paragraph will be sent to University Information Security at its-soc@nau.edu, in addition to any other notice addresses in the Contract.
- g. Security Reviews. Complete Service Organization Control 2 ("SOC2") Type II or substantially equivalent reviews in accordance with industry standards, which reviews are subject to review by University upon University's request. Currently, no more than two reviews per year are required.
- h. Scanning and Penetration Tests. Perform periodic scans, including penetration tests, for unauthorized applications, services, code and system vulnerabilities on the networks and systems included in the Contract in accordance with industry standards and University standards (as documented in NIST 800-115) or equivalent. All webbased applications (e.g. HTTP/HTTPS accessible URLs, APIs, and web services) are required to have their own web application security scan and remediation plan. Contractor must correct weaknesses within a reasonable period of time, and Contractor must provide proof of testing to University upon University's request.
- i. University Rights. The University reserves the right (either directly or through third party service providers) to scan and/or penetration-test any purchased and/or leased software regardless of where it resides.
- j. Secure Development. Use secure development and coding standards including secure change management procedures in accordance with industry standards. Perform penetration testing and/or scanning prior to releasing new software versions. Contractor will provide internal standards and procedures to University for review upon University request.
- 73. <u>Federal Funding Provisions</u>. If this Contract or purchase order issued for Goods or Services performed under this Contract involves the use of United States federal funds, including from a government grant or funds from a subcontract at any tier relating to a federal government grant, the following terms apply to the Contract:
- a. Byrd Anti-Lobbying Amendment. If the Contract is for one hundred thousand dollars (\$100,000.00) or more, Contractor will file the certifications required by 31 U.S.C 1352 and associated regulations. Each tier certifies to the tier above that it will not or has not used federal appropriated funds to pay any person or organization for influencing or attempting to influence an officer or employee of any agency, a member of Congress, officer or employee of Congress, or an employee of a member of Congress in connection with obtaining any federal contract, grant, or any other award covered by 31U.S.C. 1352. Each tier will also disclose any lobbying with non-federal funds that takes place in connection with obtaining a federal award. Such disclosures are forwarded from tier to tier up to the University.

- b. Debarment & Suspension. Contractor represents and warrants that neither it nor any of its subcontractors supplying the Services have either directly or indirectly or through subcontractors, been suspended, debarred, or otherwise excluded from participation in or penalized by any federal or state procurement, non-procurement, or reimbursement program. Contractor affirms that it has confirmed the above statement by checking The System for Award Management (SAM) www.uscontractorregistration.com within 180 days prior to commencing work under the Contract. Contractor will provide immediate written notice to the University upon learning that it or any of its subcontractors are under any investigation or proposed action that could result in such exclusion, suspension, or debarment.
- c. Rights to Inventions Made Under a Contract. If this Contract is a "funding agreement" under 37 CFR 401.3, the Parties agree to incorporate by this reference the standard patent rights clause found in 37 CFR 401.14 and any implementing regulations issued by the awarding agency.
- d. Contract Provisions for Non-Federal Entity Contracts Under Federal Awards. To the extent any of the provisions of 2 CFR Appendix II to Part 200 apply to this Contract, such provisions are incorporated by reference.
- 74. Government Subcontract Provisions. If a purchase order issued for a Service performed under this Contract is a subcontract under a U.S. government prime contract, the clauses referenced below of the Federal Acquisition Regulations (FAR) and the Defense Federal Acquisition Regulations (DFAR), or the Armed Services Procurement Regulations (ASPR) are incorporated into the Contract by this reference. Each regulation contains criteria for determining applicability of the regulation to a particular contract.

In the following clauses, the terms "Government" and "Contracting Officer" will mean the University; the term "Contract" will mean the Contract and the term "Contractor" will mean Contractor. Contractor will comply with all applicable federal laws and regulations, including but not limited to Uniform Guidance (2 CFR Part 200) and Debarment and Suspension (45 CFR 620).

For purchases funded with federal funds, the following provisions are incorporated into the Contract by reference where applicable and form a part of the terms and conditions of the Contract. Contractor agrees to flow down all applicable clauses to lower-tier entities.
