Institutional Remedies

Supportive measures and remedies may be temporary or permanent free services offered to affected parties. These measures serve to restore or preserve equal access to educational programs and services. They do not reflect decisions or opinions about responsibility. Before or without the existence of a formal complaint, supportive measures are available and may be enacted swiftly.

Supportive measures or remedies for affected parties might include: Mutual no-contact orders, changes to on-campus housing assignments, temporary emergency housing (for off-campus students). modifications of work, class or activity schedules, academic adjustments, additional measures also may be possible.

Confidentiality

Confidential assistance may be obtained on campus from Campus Health Services.

Due to reporting responsibilities, reports made to university officials are not confidential. Privacy will be vigorously respected and protected in each report of sex or gender based violence. However, when limits on confidentiality exist due to legal or procedural standards, those limits will be reviewed with persons reporting sex or gender violence to ensure their understanding, and where possible, their choice in decisions which drive reporting processes.
