Approval of Minutes

Chair Marks: If there are no corrections, the minutes are approved.

Call to the Audience

Item A: Health and Human Services – Dean Ransdell

Speaker: There are six departments and one school within the College of Health and Human Services. The school of nursing, physical therapy and athletic training, dental hygiene, health sciences, communication and speech language, occupational therapy, and physician assistant studies. We have a lot of programs down in Yuma, Phoenix, and Tuscon. We have thirteen accredited programs within our college which keeps us really busy. All of the accredited programs have certification exam pass rates that are above the national average. The students complete over 570,000 hours of service work per year. We are out in the community. We have a significant presence all over the state. We have four U.S. ranked programs. One of those is nursing which is highly ranked. The others are physical therapy, speech language pathology, and most recently physician assistant studies which is #37 nationally. Dental hygiene has a clinical site on the Hopi reservation and students do rotations out there every semester. Occupational therapy has the only public accredited doctoral program in the southwest United States. Students in the communication studies department won the state championship quiz bowl last spring

defeating both ASU and U of A. The physician assistant studies department recruits, retains, and graduates the highest number of underrepresented students which is one of the reasons why the program is ranked so highly. The students then go back and work in their underrepresented communities. The athletic training program serves athletics teams at the high school and college levels.

Item B: NAY FY20 Tuition and Fees Update – VP Jane Kuhn and VP Bjorn Flugstad

VP Jane Kuhn: We are here to talk to you about next years tuition rate for next years incoming students. Housing rates will be increased by 2.32% which is a fairly low rate and reasonable. Dining will be increased for new meal plans will be 2.93%. We have the continuing student pledge for two years. We are proposing an increase to the health and learning fee for counseling services of \$25 per semester, or \$50 a year. The green fee is an increase of \$10 per semester, or \$20 a year.

VP Bjorn Flugstad: Next year for incoming students, the pledge rate, will increase 2.50% for the base tuition rate. This is the lowest base for the pledge tuition program since it's inception. In 2008 it was 2.80%. What that means in dollars is \$260 for in-state. The HLC increase as well as the green fee increase would be an increase of 2.9% with all the other fees. \$332 overall. For undergraduate state wide campuses is a 3% increase. We looked at needs across campus and we tried to keep this increase as low as possible and we felt that 2.50% would do that. We are also making a conscious effort to look at course fees as well and trying to eliminate them where we can.

Senator Majkrazk: Has tuition been raised every year since the pledge increase implementation?

VP Bjorn Flugstad: A new pledge rate has been set every year since it was originally set in Fall 2008.

Senator Majkrazk: Do you know what the highest increase was?

VP Bjorn Flugstad: I think it was about 18% for those students starting in Fall 2009. That was followed by 14% and 15%.

Senator Majkrazk: Do you know what the tuition was at the start?

VP Bjorn Flugstad: \$5,150.00

VP Jane Kuhn: On the state-wide campuses the tuition is lower and will continue to be lower than it is on the Flagstaff campus. For the class fee reductions, the change was from 25% to 16% of courses that will have class fees.

VP Bjorn Flugstad: About a third of our classes had course fees in 2011-2012 so we've basically cut that in half.

Senator Schonbrun: Since we are lowering class fees are there any plans to lower other fees, like the athletics fees?

VP Jane Kuhn: Not at this time but they are going to continue to look at course fees and we will hopefully get rid of all of them in the future.

Senator Hernandez: Would this course fee be per department?

VP Jane Kuhn: A course fee is related to a specific course but a program fee is related to a specific program. Those are usually for programs that are more expensive to deliver than other programs, for example nursing. That will start second semester of sophomore year since students who are accepted into

the program can start taking some of those courses then.

Senator McClintock: How would that work for courses like bio where there's labs?

VP Bjorn Flugstad: That's one of the things we're looking at. Those lower division course that do have a number of students from across the university. It is more difficult to eliminate the course fee in those courses.

Senator Nardi: My concern about increasing a program fee, for example within the business college, currently we don't pay very many course fees and a program fee would actually have me paying more than what I currently pay. That's just for me so I can't speak for others but I assume its somewhere near that. Are you coming at this from a cost savings standpoint or is it to put money back into the college?

VP Bjorn Flugstad: It's to be able to increase support in the college but it's also an efficiency aspect as well because if you have a program fee rather than ten or twenty different course fees it's a little bit more efficient to manage. It's a combination of both.

VP Jane Kuhn: We're eliminating about 250 course fees but that's not going to equate to 20 program fees. Some course fees are being eliminated and there's no program fee associated with it. There are very specific programs that are more expensive to deliver that we need to put funding back into while at the same time eliminating course fees. At the undergraduate level we only have about a dozen program fees.

Senator McClintock: How would that work for minors and would program fees be charged to students as they're seniors or would it be all four years?

VP Jane Kuhn: It depends on when you're in the program. There are some program fees like engineering that will start when you're a freshman, then there's some that aren't charged until the upper division course work.

VPAA Marks: What about students who are in multiple programs?

VP Jane Kuhn: For double majors? They would have to pay both program fees.

Senator Burke: As a student when I see a course fee I know what the money is going to. I think it's a little less transparent if it goes into an entire program.

VP Jane Kuhn: Program fees have to be transparent as well. Program fees support the program, they don't go back into central or treated like tuition. All the fees will be made public on March 22 and all current fees are on the website.

Senator Nardi: In terms of the tuition and fees increase why is it so low compared to the other years?

VP Jane Kuhn: Because we are being very conscientious of total cost of attendance and this was a year that we could keep it low.

Item C: High Pine Awards - Jo Williams

Club Manager, Jo Williams: The High Pine Awards is an end of the year banquet that recognizes clubs for their hard work throughout the year. There are 20 awards clubs can nominate themselves for. There will be club performances, snacks, and a photo booth. This year the event theme is red carpet. All clubs are welcome to participate.

Item D: HLC Fee Increase

Note Submitted student comments are located at the end of this document.

Student: It is my personal opinion and the opinion of others that I have talked to that the HLC fee will not help us. The fact is that even if we hire more counselors it doesn't encourage students to go or that many students don't trust our present counselors that we have on campus. I know students who have had panic attacks after going that were caused by the counselors. In addition, raising this fee will cause students such as myself to transfer to other schools where the counseling is free and they do have a reputation for making sure students are okay. That is currently something that isn't at NAU. Raising the fee would add more counselors and might show on paper but realistically you're just adding more people.

Student: We should increase this fee but we should be transparent in the way that we do it. I think the college culture right now isn't that we just go to school. We go to school, we have jobs, extra-curriculars, and this causes stress. One of the biggest things is the stigma. With stigma it's hard to break that. We should raise our efforts to provide mental health services to our students. Yes there have been negative experiences with our counselors from what I've heard and seen but that's also because we only have a handful. To address the problem I think we need to increase the number of supporters and professionals we have because it's hard to get the results we want if we are so understaffed.

Student: I think this fee is very important. Mental health issues are a nationwide problem and NAU is seeing an increased rate of depression and suicide so I think in order to stay on par with what is happening at other universities it's really important to take into account these issues. I know ASU and U of A have implemented similar fees and I think if we want to attract students to our university we need to be able to provide that mental health support. I do understand that some students have had negative experiences with counseling services but it's important to remember that every person is an individual and not every counselor is going to work for every individual. It's very difficult for students to go to outside providers because a lot of them are filled up and not everyone will take insurance. We do have a waitlist right now of over 150 students so the demand isn't being met currently. In order for us to better serve our students it is important to take into solutions and I think a fee increase is a good solution.

Unfinished Business

New Business

Chair Marks: For all clubs, organizations and individuals here today, thank you for being with us! When I call your name please come to the podium and give us about a 2-minute-long description of what the funding is for or why you would like to become a club and how it will benefit the student body. All questions will be saved for the voting period.

Item A: Club Recognition: Jews for Equality

Speaker: This is a club based on getting more representation for Jewish students on campus. All too often Jewish students face crimes of hate, such as having Hitler being written on somebody's door. This club is to teach students about the Jewish faith as well as fighting for equal representation on campus because many resources on campus focus on the majority rather than minorities. The Jewish population isn't as large and therefore doesn't get as much recognition. The students are not required to be Jewish to join, they are just required to have a passion for equal representation and standing up for a group of people who are discriminated against far too often.

Item B: SB 31-131: ASNAU Graduation Stoles

President Graham: I am asking for funding for the ASNAU Graduation Stoles. It's a great incentive for

our ASNAU seniors who have done so much for the organization as well as the student body and they will get recognized at the NAU commencement ceremony.

Item C: SB 31-132: ASNAU Earth Hour

Sustainability Coordinator Morale: I have been working on planning Earth Hour for a few months now and it's going to be a really awesome event. We're just asking for your approval to be able to spend over \$750.00.

Item D: SB 31-133: Arizona Playmakers

Speaker: We are requesting funding to go to FRAVUS Improv Festival at USC. We've gone the past four years and it is hosted by USC and improv groups from all across the southwest attend. There are workshops led by them. It is good for our club because we do improv but also for different artistic opportunities from across campus.

Item E: SB 31-134: Brooke Nyberg

Statement: The purpose of the Society for Industrial Organizational- Psychologists (SIOP) conference is to enhance and spread current research about workplace psychology. I-O psychology is a field that works to better employee relations and environments, learn how to successfully hire new employees, reduce workplace discrimination, and more. By attending this conference, one is able to share knowledge and gain a better understanding of important research and opportunities within the I-O field. I am requesting reimbursement for the cost of the hotel, which seems more expensive due to the conference being outside of the main areas of Washington DC. In addition, I am requesting funding for the cost of the flight and for the conference fee. Gaining the opportunity to present a poster and attend the conference for SIOP will be beneficial to me and my peers in multiple ways. First, it gives me the ability to enhance my presentation skills, especially because it is being presented to people who are in the field of I-O psychology. In addition, it will help me to increase my connections with other students and faculty members at other schools which will also allow me to spread NAU's name. I-O psychology is a less commonly known field of psychology, therefore it is important for other schools to know NAU's addition to the research. In regard to the student body, I will be able to spread the knowledge that I am receiving at the conference to other students who are interested in I-O psychology. More students may also become interested in furthering their knowledge of psychology by knowing there are opportunities such as conferences and research projects. I was fortunate enough to have a research project that I am first author on be accepted to this conference, therefore I am very excited about attending this year and greatly appreciate the opportunity to possibly receive funding.

Speaker: The money will help us save what money we do have as well as help us continue our team and continue competing in the league that we are in.

Item G: SB 31-136: Kendall Mesa

Speaker: I am seeking reimbursement for a trip I took to Los Angeles about two weeks ago. The trip was to go to LAX and I was then flown to Australia for a training to run a program back here on NAU's campus. It's called AIM. It's a mentoring program that started in Australia that they are now bringing to the U.S. We partner with a high school and mentor a certain demographic of students facing inequality. The demographic that we chose were students with mental health disorders. I think that being able to be trained there will help me run the program successfully here and help these high school students.

Speaker: I'm seeking reimbursement for gas and entry into a tournament we had a few weeks ago down in Phoenix. Your support for us helps us keep an expensive sport very cost-possible for college students.

Item I: SB 31-138: NAU Trail Riders

Speaker: I'm seeking reimbursement for registration fees to races. We are huge into being a club but also into being a family as a lot of us moved away from home. It gets a lot of students out of their dorm and gets them to look at our beautiful scenery that we have in NAU as well as in other parts of Arizona.

Speaker: I am here on behalf of our lab to ask for funding so we can present at the Rocky Mountain Psychological Association National Conference. This is a conference for young psychological scientists. We were fortunate enough to hold a symposium for the first time. In the symposium we have a couple of studies we want to present not just to the conference but to other young scientists. These include topics with race and gender and we want to know how these topics relate with young adults. We also want to look at women in STEM and the conceptions of what a woman in science is and does. We are seeing funding for the cost of the conference because it is expensive. This would be a good opportunity for us to interact and network. Overall this would be a really good experience and we would be able to represent NAU because we are holding a symposium.

Student: Mental health is a big deal on college campuses. The suicide rates at NAU are twice the average and I think that should be looked at. The waiting list is super long and it's great that they're helping crisis students but 250 on the waiting list is extreme and things escalate. They may not be in crisis now but not

getting help can cause things to escalate.

Senator Schonbrun: I had sixteen students tell me no and two said yes when I tabled.

Senator McClintock: Yesterday we didn't have as many people come but everyone who did come said yes.

Senator Hernandez: I didn't have a single person say they were against it.

Senator Martinez: I did two polls and I got about 150 no's and 36 yes's.

Senator Nardi: Was there any reason why the no's were so high?

Senator Martinez: All the comments that were left were saying that they didn't want to pay extra money since we are already paying so many fees. They want to see money reallocated.

Senator Majkrazk: I think students financial concerns are very valid and I think we need to weigh the benefits of this fee versus the consequences of not having it and they could be drastic. I think we need to consider that this fee will impact students financially but compared to tuition and all the other fees it's a very small increase and there are a lot of benefits.

Senator Hernandez: There are a lot of concerns about tuition going up but tuition isn't going to go up, it's locked. Other universities who do increase tuition increase it by a lot more than \$50 a year.

Senator Schonbrun: There were four major concerns from students. First was that the fee was too expensive. I talked to a few students who said if these fee's pass they won't come back because it would be cheaper for them to go somewhere else. If we're having people leave because we keep increasing the prices that's a problem. The next was the idea of the tuition increase. Calling something a fee is something that would be a tuition increase anywhere else. The tuition pledge was marketed as you're not going to have to pay more. That's how it was marketed in high schools. The idea that you can call something a fee and still pass it was outrageous to a lot of students I talked to. Another concern was how long it's going to take to hire counselors. How long does it take?

HLC Fee Representative: Anywhere from three months to over a year. It depends on the pool of applicants we get, where they may be moving from. It could take a while. We want to get these positions posted as soon as possible so we can have as many on campus by next year as possible. It takes a long time to hire these types of professionals. We'll be doing a national search and outreach to publications.

Senator Schonbrun: So there's a possibility that the fee would go into effect and they would be paying for the next generation of high school students and not students who need it at the moment. Finally, there were a lot of students who were upset about all these other fee increases we've had and basically that there's no accountability. This fee was pushed to the end of all of those and it seems like they know we aren't going to vote no on helping other students mental health so it kind of seems like the university is trying to have its cake and eat it too according to these students. Those were some major concerns that I've heard and I think we need to talk about those before we vote on this.

President Graham: I have a question for Senator Martinez. Was kind of poll was this?

Senator Martinez: It was on Facebook through a NAU group. So everyone in it is an NAU student.

President Graham: I would say that's an unofficial poll then. I appreciate that it's an NAU group but it

would be hard to verify that they are all current NAU students.

Senator Nardi: I would like to address a few points that Senator Schonbrun made. One of them being the difference between tuition and fees. I do see the distinction that tuition is for classes and not attending the university. In terms of talking with students, I found that as soon as you mention the HLC fee increase they say no but once you explain it a lot of them say it's going to a good cause. In terms of the fee being delayed so the current students don't see the benefit of it, I think that's unfortunately unavoidable. It's going to take time to hire people and there are going to be upfront costs that are going to need to be paid. As an RA for the past few years I've dealt with a number of crisis situation and it's pretty amazing that the counseling department has readily available on call counselors to handle those but unfortunately they're so backed up in their office that past those emergency visits it's very difficult for students to get further help. I think overall that there's a lot of benefit to this and addressing the mental health of students.

Senator Burke: I wanted to backtrack on a comment that was made. The waitlist isn't quite 250. It's about 150.

HLC Fee Representative: It's currently 187.

Senator Hernandez: I have two points. My first point is that NAU is like a society and part of being in a society is that people should take care of each other. This fee would go towards taking care of as many people as possible. Second of all there was the concern of having your cake and eating it too. All fees proposed to us because the university thought it was necessary in order to continue improving the campus. These fees aren't being proposed for malicious intent or to impose more fees on students.

Senator Schonbrun: The issue wasn't that we need to help students with mental illness. Nobody is saying that we should ignore that problem. The issue is the way this is being imposed. Students were mad when they saw that only a small percentage of the HLC fee is going to counseling. They feel that the money needs to be reallocated from other places on campus. The idea that we have to pay an additional fee was the idea of having your cake and eating it too because you still have to pay for these services and the services that students actually need are the last ones to be thought of. The idea was to reject this so we can decrease a fee or pass this another way. They said there are only two ways we should consider these fees. One, every student receives free counseling. Two, that it comes from another fee that is unpopular. The idea wasn't to ignore this problem, the idea was that there needs to be other ways of funding this.

Senator McClintock: A lot of students go to counseling and you can see that from the numbers. What you're saying about still having to pay for it, it's \$25 a session. If you get an appointment every two or three weeks throughout the school year that adds up for students and for students who rely on financial aid that financial aid doesn't pay for those appointments. They will not accept insurance at counseling services and for those who don't have positive experiences, they don't see it as worth it to go back if they can't afford it to begin with.

Senator Hernandez: I believe that students who need counseling should get counseling. Students who really need counseling, it's still a lot more expensive to visit an off campus mental health expert or anything else that they need. I think we need to make it more accessible on campus and by putting more

counselors in place it would help increase the quality of counseling that students get.

Senator Schonbrun: While I understand that counselors should be more accessible the simple fact is that we have students who have to leave because of rising costs. Flagstaff has a high cost of living and combine that with tuition and the fees that we have, it's cheaper for students to go somewhere else. There's a reason why we have programs like Louie's Leftovers. Students do not have this kind of money. We keep getting told these are small fees, these are small fees, there are always more. If we keep having these fees the numbers will continue to add up. It's good that were addressing concerns about mental health but what about the concerns of the students who can't pay?

Senator Nardi: It is \$50 a year and to have to leave campus because of \$50 seems a little drastic. I have a question [for the representative]. In the event that this doesn't go through is it even possible to reallocate funds within the HLC fee or are all of those funds being used? My second question is if it would be possible to reallocate tuition funds?

HLC Fee Representative: Right now the \$500 fee that we're collecting is 100% distributed with a large portion of it going to the debt service on the building. Being able to build that building was the original reason for the fee. About 68% goes to debt service and 32% goes to the rec center and health promotions center. We do put a small amount of money away into a reserve which is the fiscally responsible thing to do. Because of that reserve we were able to replace the turf fields on the south fields over this past summer without having to ask for something. Could we reallocate within that? We have to pay our debt service. We could increase fees in the rec center and reallocate those. We would increase fees in the health center but I can tell you that we won't generate enough to meet the needs. If we increase fees in counseling we will see our demand drop. We will have students who need counseling services who will not seek counseling services because of the cost. We won't raise enough to make a difference either. \$25 might be a barrier but if you go out into the community you'll pay at least \$100 for the same thing. The first visit is free so we're trying to lower costs. As a fee versus tuition, it has to go towards what you all pass it for. If it's passed for counseling it has to go towards counseling. The state auditors office will audit us. Under tuition it may go to counseling this next year but the following year there might be a different priority and that money won't go to the counseling center. Adding it to tuition, it becomes discretionary. If it's passed as a fee we have to follow what it's put towards.

VPAA Marks: I want to remind the senators that you're not voting based on your opinions. You're voting based on what the student body wants. When Senator Schonbrun mentioned the \$50 there were a lot of negative reactions to that but not everyone has the same financial standards. You can't have negative facial expressions because you think that's not big. We don't know the financial situation of every person here. We're here to speak on behalf of the students.

Senator Rose: Based on the students I talked to in my classes, one student who stuck out in particular, they said that you're not going to understand how important one or two counselors might be until you lose somebody to suicide which is a big problem at NAU. I understand that two counselors might not seem like a lot but if one of those two people were able to talk to that one student who who lost their life it would have been worth it.

Erin Grisham: There's questions about fees and that process but there is an audit that happens annually. ABOR has a new process for all three universities to look at all fees and to get rid of or revise those that are no longer necessary.

Dear ASNAU senators,

I am a student who strongly supports the \$25 fee increase to expand NAU's counseling services. The emails I'm forwarding to all you highlight how difficult it can be for students to get help, even while in crisis. I'm the student anonymously mentioned in these emails as being unable to get an appointment. I started having problems in October and was unable to get an appointment until January, and unable to get a consistent counselor until almost February. The lack of resources also negatively impacted me when I had a crisis appointment last month. I was told that since it was my second crisis appointment I would likely need to look for an entirely new counselor off campus and start over from scratch. My usual NAU counselor who I see weekly is amazing, but I feel strongly that it should not have taken so long for me to be able to meet with someone. Please support this fee increase so other students don't have to go through the same situation.

Good afternoon,

I am not sure of the best place to send this, but I am extremely concerned and I would like to be assured that my message will get passed on to the right place.

I am contacting you because I have become alarmed that students are unable set up a counselling appointment at Campus Health Services. I was sure at first that there must have been a mistake, but 2 students have now told me that they have been turned away. It is understandable that things get booked up, but it seems crazy to me that students will not be able to get in to see a counsellor until 2019.

The mental health of our students is (obviously) extremely important. These 2 students feel that they cannot get emergency help because they are not in what would qualify as an “emergency” situation. However, as time has passed on and they have continued to feel the lack of support with their mental health, I know that on one account the student is starting to go into a crisis. This particular student who is having a mental health crisis has tried going into the community to find a provider, but the hours that they are available do not work with their busy school and work schedule.

No one asked me to send this message, but I felt that it needed to be addressed, as the mental health of our students is at risk. I have provided the Crisis Response Network and NAU Counselling Services On-Call contact information to the students.
