

Jim believes in the power of freedom and equal opportunity and knows that with freedom comes responsibility. Shunning a set ideology, he seeks out practical solutions.





Ducey was previously the CEO of Cold Stone Creamery and was Arizona State Treasurer from 2011 to 2015 before taking office for Governor. Because of Arizona's term limits, he cannot run for reelection.

#### Position:

The Arizona Secretary of State's office is charged with several important state functions, including serving as acting governor when the governor is absent from the state. Like lieutenant governors in other states, the Secretary of State is first in line to succeed the governor in the event of death, resignation, or removal from office.



The Secretary of State is Arizona's Chief Elections Officer, overseeing all elections in the state. The office ensures that elections are secure in Arizona. They record all businesses in the state and register all trademarks and trade names. The office holds all records from the Arizona Legislature and Governor.

#### Biography:

Secretary Katie Hobbs began as a volunteer at her church and continued with her job as a social worker and chief compliance officer at one of the largest domestic violence centers in the U.S.

Secretary Hobbs has a Bachelor of Social Work from Northern Arizona University and a Master of Social Work from Arizona State University. She has been a professional social worker since 1992. Prior to being elected to the legislature, she worked in the areas of domestic violence, behavioral health, and homelessness.

Prior to assuming office in January 2019, she was an Arizona state senator representing the 24th district from 2013 to 2019 and an Arizona state representative representing the 15th district from 2011 to 2013.

#### Biography:

Brnovich spent most of his professional life serving as a prosecutor at the local, state, and federal levels. Brnovich met his wife Susan while they both worked as prosecutors for the Maricopa County Attorney's office. He worked in the Gang/Repeat Offender Unit and prosecuted many difficult and high-profile cases from 1992 to 1998. Brnovich then went on to



work as an Assistant Attorney General with the Arizona Attorney General's Office (AGO) from 1998 to 2003, where he developed an expertise in gambling law. He later went on to serve as an Assistant United States Attorney for the District of Arizona where he prosecuted public integrity crimes, as well as crimes occurring in Indian Country.

Brnovich has also been a Judge Pro Tem of Maricopa County Superior Court, a Command Staff Judge Advocate in the U.S. Army National Guard, the Director for Constitutional Government at the Goldwater Institute, and the Director of the Arizona Department of Gaming, a law enforcement agency that investigates illegal gambling activity, as well as working with tribal regulators to ensure the integrity of tribal gaming.



She is the first and only African American in Arizona to hold statewide office and the first statewide elected official, west of the Mississippi. Sandra was re-elected to the Corporation Commission in 2018 on a platform of restoring integrity and transparency to the Commission, lowering unjustified utility rate increases and creating more solar and renewable energy in Arizona, especially roof top solar.

Wendy Rogers was commissioned as a 5th-generation military officer into the Air Force from Michigan State University with her bachelor's degree and then master's degree from the University of Alabama in Clinical Social Work. She began her career treating patients in the Air Force mental health clinic. In 1981, Wendy Rogers became one of the first 100 women pilots in today's Air Force by earning her wings at Williams AFB in Arizona. Following Air Force jet training, Wendy piloted worldwide airlift and humanitarian missions in the C-141 transport jet for several years. Wendy then served as a flight instructor



for cadets at the US Air Force Academy. The latter half of Wendy's 20-year Air Force career placed her overseas. While in Europe, Wendy piloted Air Force C-21 Learjets and led three different operational divisions at Headquarters US Air Forces Europe. During the fall of the Berlin Wall and efforts to improve relations with former East Bloc countries, Wendy was deployed for six months downrange to run the Bosnian Airlift. She finished her career with over 3,000 hours of jet time and numerous commendations, including the Defense Meritorious Service Medal.

After retiring from the Air Force in 1996 after twenty years of active duty, Wendy and her husband Hal (also a retired Air Force officer) started their own home inspection business. Their crew of Arizona-licensed home inspectors has worked throughout Coconino, Yavapai, Pinal and Maricopa counties. Hal is an electrical engineer who originally grew up on a Holstein dairy farm milking cows twice daily till age 18. Since Wendy and Hal relate on so many levels to the wholesome rural lifestyle of the area, they chose to make their retirement home Flagstaff's Wildwood Hills. Wendy Rogers is uniquely able to serve the needs of Legislative District 6 because she is able to pilot her own aircraft into many of the short-field runways in remote rural areas.

In addition to her degrees in social work, Wendy holds a second master's degree in National Security Studies from Cal State San Bernardino.


# FIND MY CONGRESSIONAL DISTRICT

Senator Kelly was later selected as an astronaut in 1996 in the same class as his twin brother Scott. He flew his first of four missions into space in 2001 aboard Space Shuttle Endeavour and retired from the Navy and NASA after commanding the final flight of Endeavour in 2011.



The Arizona Board of Regents is the governing board for the state's public universities: Arizona State University, Northern Arizona University, and the University of Arizona. The board provides policy guidance in such areas as: academic and student affairs; financial and human resource programs; student tuition, fees, and financial aid programs; university capital development plans; strategic plans; legal affairs; and public and constituent outreach.

The board consists of twelve members, eleven voting and one non-voting. This includes the governor and superintendent of public instruction as ex-officio members, each serving while they hold office, and two student regents.

Except for ex-officio members and student regents, the term of a regent is eight years. As regents finish their terms, new regents are appointed by the governor and confirmed by the Senate.


