Executive Reports

a. President: Maylee Acosta

I went to the Student Organization Leadership Council meeting. We talked about different ways to get funding. I know some of you have been asking about finding more funding for Dean events so I'm looking into the resources that were shared that day to see if we can make it happen!

Our Supreme Court Justice Batson went to a Parking services appeal board meeting and this is what he had to say about it:

"Today's meeting went well and lasted from 8 AM-11:30 AM. There were 25 cases to go over, with 5 in-person and 20 written. Only two in-person cases showed up, with

the other failing to make an appearance, leading to an automatic upheld citation. Of the 25 in total, 24 were upheld, while 1 was waived."

VPGA Billings, VPAA Stempak, SSA Directors Best and Trachsel and I met with Kyle from the Arizona Students' Association to discuss ASNAU support for a ballot initiative. I'm waiting to hear back from the university legal counsel to check if ASNAU can support an initiative of that sort but if we get approval, we will share that information with you all.

Executive Assistant Gilbert and I have reviewed the Budget Committee sign-up list. I went to legislative committee, Senator Handlong has been doing a wonderful job leading the committee and I enjoyed hearing their discussion.

VPAA Stempak and I met with the library yesterday. They plan to give regular reports at senate meetings and work with us closely. After meeting with the library and hearing a ton of fun facts about their history, it got me thinking about all the random, and sometimes useful, information that execs gain through some of these meetings. If you ever have any questions about anything, please come to us. We have more knowledge than can be shared in our reports. Hi, here is my report for this week.

This week I have been primarily focusing on the Student Resources Guide project that VPGA Billings and I have been planning for a while now. I created a directory

of student resources available to NAU students. I was able to compile 182 on and off campus resources and categorize them into 18 separate categories. Each resource has contact information and a brief description. This director is around 35 pages long. We will now be working on taking the directory and getting it on the NAU website in a visually appealing manner.

I have also been working on contacting sources for the Academic Advising project that I am working on. Now that I have approval from the exec team, I can share with you what I am working on. After talking with a few advisors and some very involved students, we were able to determine that the primary reason that students schedule advising sessions is because they have no idea how to use LOUIE. And then the advising session turns into a training session for LOUIE which is counterproductive and not what advisors should be spending a majority of their time working on. I am working on implementing a 4 stage LOUIE Training service for all students that will allow them to understand LOUIE before they ever have to go to an advising appointment. The stages include an Orientation training, a bblearn course shell, quarterly training workshops, and incorporating Residential College Ambassadors into the trainings. I want it to reach as many students as possible and this 4 stage plan will help. I am currently working with Louie experts and advisors on the practicality of implementing this plan. All in all, advisors should be spending their time helping students with enrollment questions, and planning for their academic career, not acting as LOUIE trainers. On top of that, I am working with VPSA Kavanaugh, Senator Cinader, and the advocacy committee to brainstorm solutions to the current meal plan issue that Jeremy brought to our attention a few weeks ago. We are still in the early brainstorming process, but I will let you know if we come up with a suitable solution.

I also attended a meeting with Kyle from ASA with the exec team and Brendan to discuss a new bill that ASA is bringing to State Legislature. Hopefully this will be a Senate Resolution here soon and we can get all of your support for the bill. Finally, I have a few updates from the Presidential Strategic Road mapping Committee. So all the sub-committees just submitted their first drafts of their strategies for the next three years. Faculty and Staff are first to review the strategies and give feedback. But once they are done it will come to the students for feedback and we would love your comments and concerns about them. I have no idea what the other committees have been working on , but I can provide some major updates on my committee, which is most in line with what students would be interested in. First, we are attempting to make a NAU wide focus shift when making University decisions. In the past it had been what is best for the department itself, but we are hoping to switch towards what is best for the student. On top of that we are going to encourage a greater level of collaboration and communication on a cross-departmental level. We want to try to get rid of the disjointedness that NAU currently has. For example, when I was compiling my student resource list, only 55 of the 182 were presented in all five of the current resource guides. That means 127 were not included. Our goal is to

create a cohesive experience for the students that isn't filled with competing and disjointed departments. And finally, the focus has shifted from the goal of graduating University. What we have noticed is that just graduating isn't a true measure of success. Instead we are going to try to implement a new policy called NAU Life Design. We are going to try and encourage students to pick a goal whether it be a career or graduate school that is further than just graduation and we are now going to measure success from that standpoint instead of solely graduation rate.

The next two articles that we amended have purposes that are related to one another, so bear with me. The first is Article 9, specifically based on Executive and Senate qualifications. Section 1 states that only elected members of ASNAU should be required to maintain a cumulative GPA of 2.75. However, in Article 26 section 7, it's required that the Justices of the Supreme Court, which are hired positions, must also maintain a GPA requirement of 2.75. Because of this, we as a committee thought it'd be best to require all members, elected or hired, to maintain a cumulative GPA of 2.75.

 - b) Level two (2): Complaints and Appeals
 - c) Level three (3): Impeach of an Officer
- 7) Maintaining a cumulative grade point average (GPA) of 2.75.
- 8) Having accumulated a minimum of twelve (12) credit hours at NAU and holding a minimum of twelve (12) semester hours during their terms.
- 9) Duties of the Chief Justice of the Supreme Court:
 - a) Calling regular and special meetings and sessions of the Supreme Court.
 - b) Acting as chairperson of all meetings and sessions of the Supreme Court.
 - c) Recommending the agenda for regular and special meetings of the Supreme Court to the Supreme Clerk.
