Call to the Audience

a. John Georgas: LMS

John Georgas: Thank you everyone for giving me some of your time. I am John Georgas, the Vice Provost of Academic Operation, and in the past I was a faculty member in computer science. I am here to introduce/share information on reviewing the current Learning Management System. This we know as BB Learn, or originally "Course View". Our contract with BB Learn Expires in the summer of 2023. The centrality of BB Learn

in the ecosystem of the university, we are trying to get an early jump of reviewing our needs. We're thinking through what criteria we should use to decide on what the next LMS should be. (Shares Screen) This is an information portal that lays out some details about the process. I have alluded to the why, the contract is expiring. This is a natural point to think about what the features we want to make sure the next LMS has, what nonfunctional properties (e.g., Mobile friendly). What are the properties that the next system should embody? We are trying to do this in an open consultative way. I hope this is the first of some subsequent visit here to keep this group posted, and to show how students can contribute as we go through this process. This enables us to have an open conversation about what is a major purchase for the institution. We're limiting our choices to one of the three LMSs that Arizona universities already have a contractually relationship. The three LMS candidates we have is BBlearn ultra, which is the next generation of bblearn, it is different than the current course view. We are looking at canvas, it a more commonly used system. Also D2L. ASU is a Canvas school, University of Arizona is a D2L school, NAU is a bblearn school. Were limiting our choices with the three, it lets us be open with the process, that we reach the decision. Were working on now is how were going to make the decision. Were listening from the community, establishing what the criteria is. When the spring semester comes, were going to use the criteria we've established this term to make the decision. The entire campus community will be involved in this process. The next steps and opportunities for you and your constituents, students and students. In two weeks, we will be launching course sandboxes that will gives you bblearn ultra, canvas, and D2L course shell, so that if you're not familiar with the systems, this gives you the opportunity to mess and play with them. In

addition, we will be launching a questionnaire that is going to be shared with the students, it will be a survey type to get feedback from the student perspective that we may have missed. What I would love to hear from you is what are the things that are critically important that the LMS staff need to support? What is the stuff that the bblearn course views gets wrong?

Senator Carter: Thank you for bringing this to us, I can't think of any problems that students have had, but some of my professors have had difficulties. One professor doesn't use bblearn for grading anymore, one only send email announcements and has us email our work to her, that's all I've noticed so far.

John Georgas: That is useful feedback, we have faced challenges in getting faculty to learn bblearn. We understand there is the question of when this will impact you. Students will not see these changes until the Fall 2023 semester. We're making the decision now, we will then make the migration and transition towards the new system over a year. Bblearn will be the LMS that will be used to deliver instruction, the transition will be until Fall 2023.

President Acosta: I was wondering if MS Teams was an option? One of my professors uses it and I like it.

John Georgas: MS Teams has come up; it is not quite fully featured of what an LMS brings with it along the lines of functionality.

Senator Fox: I've used canvas, and it doesn't have Duo security. Is that something exclusive to BBlearn or is that something on NAU's side?

John Georgas: The Duo security is separate from BBLearn but it goes through our single sign on. If you had to pick, which LMS would you choose.

Senator Fox: Canvas is more organized and professor friendly, the inbox is not the best. It

was friendly to have something simplistic. I think BBLearn is better about messaging

systems. Canvas has a better announcement and calendar section. I do like that BBLearn

organizes its courses, the way it is laid out is not as friendly as Canvas.

President Acosta: What do you want to see from us? How would you like us to help?

John Georgas: There will be a blast message about the survey sent out, this group would

help weighed in an encouraged others to participate. In the weeks to come, I would like to

schedule a 20-minute slot to reconnect and provide an update to this group.

Senator Arnold: Will there be a link we can send to others to share information about the

survey?

John Georgas: When we send the blast email out, we will make sure to make all of that

information available.

Senator Massey: (Presents SB 34-9) The NAU Film Society has filmed the production of

"Red Light". They have been filming for the past couple of weeks and requested \$2,000

from ASNAU. This is to promote the film. We will be reimbursing for the speakers,

performers, the artists, general materials, and marketing of the event.

Film Society Members: Hello everyone, I am James, the treasurer for the NAU Film Society, this is Madeline, she is our Vice President. Our project "Red Light" is a short film based around the idea of a psychological thriller and what is going on in people's heads. It is an experimental film that the audience dives into the head of the main character who has anxiety. It deals with the roots of anxiety and getting over it in the end. It is art heavy and will have a lot of art. We're here for reimbursement, that is the major focus for the \$2,000. Its not the full \$2,000, its just up to. Our grand total was \$860, that factors in the tax. We are looking to get the costumes, set design, props, and additional costs. The project took place over two weekends, it is complete now, and we have all of our receipts collected.

Senator Carter: I was in appropriations discussing this. Will this project be distributed to students in some way?

Film Society Members: We intend to create something every semester as students filter in and out of the department. We bring in new people, train them, and at the end of the semester we film and go through the editing process. Then distribute so the student body can see. We want to incorporate more people from outside the department. Our people are learning budgeting and finance, even if they're coming from the film department. In terms of sharing the content, but I cannot give you a date right now. It is in early edit, there is potential it may be released next semester.

Senator Carter: I know it says we're reimbursing general materials, but it also says speaker performer artist, is that compensation for those?

Film Society Members: I understand if that is not coverable, we typically cover that cost

on our own. That expense would be the talent for the film, there was one major actress

for most of the shoot, then a couple extras. The idea is yes to incentivize, and to get more

professional talent. We want to have the professional ability to pay for the day, especially

for small local talent. More for the main actor/actress than less for the extras.

Senator Machelor: Will you be presenting this at a film festival?

Film Society: We tend to do so, there is another club, UTV. They tend to host a film

festival at the end of the year.

Senator Carter: I am in support of this bill. Although, in our bylaws, in article 32, section

6. We will not reimburse clubs/organizations for wages.

President Acosta: We've had previous discussion about the LEAF Bill before. We were waiting to receive a finalized number. The LEAF fund provides COVID relief for all NAU students. Something we added to this bill for something that we're providing is going to Flagstaff Undergraduate Students. We came up with the number \$65,000, this is the average that LEAF will be spending this semester. \$65,000 will be given for the spring 2022 semester.

Senator Machelor: On the 6th whereas, it says "Distributed in the Fall 2021 semester" is it supposed to be Spring 2022?

President Acosta: I included that as background, it was supposed to be distributed in the fall.

Senator Carter: I know you mentioned some hiccups with making sure these funds go to NAU undergraduate students, is there any clarification on that process?

President Acosta: The amount we approved previously was \$100,000. That was for all NAU enrolled students. I was given clarification that we can put restrictions on the funding that we're given. \$65,000 would just be for the Flagstaff undergraduate students. Senator Carter: In the first whereas, it says "The LEAF Fund will be distributed in Fall 2021."

President Acosta: The funds that we're giving is at the end of their distributing period in the spring. Anything that we're giving will be distributed by the end of 2022.

of \$2,000 for new gym equipment for the AROTC club. They meet on Monday,

Wednesday, and Friday. These materials will be staying within the club. They have

requested kettlebells, dumbbells, and weight sled, etc.

Axe Org: Hello my name is Sam, I am apart of the AROTC program, president of the

Weightlifting club for Axe Org for the student government of AROTC. They are

sponsoring and requesting funding. The gym is located in the Beaver Street School

Gymnasium and a couple classrooms has been used for the ROTC club M, W, F.

Preparing for the ROTC fitness test for muscular strength, and overall fitness. Any

equipment that is purchased will be staying at Beaver Street, or any location that ROTC

will be using. It is possible that the Air Force ROTC will be joining with the club so that

more people will be able to use the equipment. Right now there aren't many that use the

equipment. There is one bench press, we will be getting one of those. We need more

equipment to get better physically.

Senator Carter: Will this be available to be used by the entire student body?

Axe Org: No, just the point of liability for the Weightlifting club, everyone in the ROTC

program has signed a waiver that protects the program and the school from any injury.

That is not feasible with the rest of the student body. I am talking with one of the ROTC members that coordinates with NAU about the status of the club. So that the rest of the student body can use the equipment.

Senator Carter: In our bylaws, what we will not fund is reimbursement for club uniforms, jerseys, and or sports equipment that will be kept by the organization. That merchandise will need to be made available to all the student body for us to fund it. I know you are discussing that with other, is there any guarantees that will happen?

Axe Org: At the moment I cannot guarantee that will or will not happen. As the student government for ROTC is delegating it to us, the Army as a whole gives each school a certain amount of funding, we've already used that amount.

Senator Fox: I talked with someone who is in the Air Force about the ROTC situation. She said there was an area by the skydome. Which is where the ROTC people meet, is there anyway you can store the equipment in there to make it available to the student body?

Senate Chair: Are you also with the lifting club on campus?

Axe Org: It would be the ROTC lifting club.

Senator Fox: She told me that ROTC met there, that possible for equipment to go there? Axe Org: I don't believe so, what I think you're talking about is a shipping container between the ROTC building and the other building.

Senator Fox: There is no room that ROTC can put this equipment, maybe somewhere off campus that way you can make it available to other students?

Axe Org: Right now, the current location we have in the Beaver Street School, we have the gymnasium and a couple other classrooms which equipment is already stored.

Senate Chair: Point of information, is joining the AROTC open to the student body?

Axe Org: Yes, anyone can join at any point, you just need to enroll in PT. In a class, and both programs have labs to enroll in.

Senator Machelor: Have you contacted the HLC for using their gym before opening hours?

Axe Org: I have not purely because we have training from 6-730 am in the morning. Some ROTC members have classes at 8 am. Lifting during HLC times would not be useful.

Senator Arnold: As we all know, the bylaws are up for interpretation for any given year senate. I would not classify ROTC as a sport.

Senator Fenn: Anyone can join ROTC, but is your program separate?

Axe Org: Anyone can join, you need to be in the program and need to sign a waiver for the program and school. Everyone in the program has signed a waiver so they can participate in the lifting club.

Senator Fenn: Anyone can join your program if they join ROTC first?

Axe Org: Yes.

Senator Carter: Weightlifting is a sport; it is an Olympic sport. I have an idea that could solve a problem. Ya'll could do a monthly open lift night to that is open to the student body, people can sign the waiver there. This would be good to try to get people for ROTC as well. I will be voting no on this, but I think there are other ways this can be accessible to other students. I appreciate you being diligent with your answers.

Axe Org: Thank you, I appreciate your answers. A couple things, Olympic lifting is separate from power lifting, and regular lifting.

Senator Carter: Is ROTC, do you disclose that you are from NAU?

Axe Org: You're speaking about the physical fitness test. You do a commission throughout all four years that you are in the program. I believe you do the test twice a semester. There are active army personnel that get the numbers and submit them to cadet command that is the portion of the military that determines where our ROTC program is. Senator Arnold: In the bill, the 3rd whereas states "the purpose of this event is to help the Army ROTC meet and exceeds the fitness standards of the Army and represent the program for something that it is, exceptional. I don't see how this is any different than what we just passed, with helping Ricardo with his exam reimbursement, or any other club event that they have put on. ROTC is a club, we have reimbursed the Birds Aren't Real stickers, or things for the carnival stand, I don't see how this is different that any other reimbursement.

Senator Davidson: I agree with Senator Arnold, we reimburse a lot of things, some things that are not for everyone. For example, the LGBTQ scholarship that doesn't go to me, but to many other students. The same with the ROTC program. As long as were helping NAU in some way, we are doing our job.

Axe Org: At a basic level, if the lifting club were to get this funding. The lifting club will benefit the most, but the next level up will be the ROTC and Air Force program will benefit as well. If both ROTC and Air Force ROTC do well on their physical tests, this can be considered a varsity sport. We have a competition team in Fort Bliss, TX, if their physical fitness does well in the competition, that will look good for the NAU ROTC.

This tell other colleges and the Army that NAU can produce good students and good

cadets. It does only help a certain amount of people, but when you look at the extent of

what the program can do, it gets the NAU ROTC name out there in a positive light.
