Approval of the Minutes

Since the meeting minutes have not been completed, we will be approving the meeting minutes for last week and this week.

Call to the Audience

- a. Library – ASNAU \$60K Overview (Andrew.See@nau.edu)

Andrew See: Hello everyone, I have a PowerPoint slide. I am here to talk about our longstanding relationship with ASNAU and Cline Library. A powerful collaboration, whether you know or may not know. Our partnership is regards to our late-night hours

that started in 2010. We are now closing at 2 am, at the time we were closing at midnight. At the time of the change, this was driven by the ASNAU initiatives committee that was approved through the board of regents, that partnership has held strong. However, in 2019, the library leverage that was existing in ongoing collaboration and funding that was being provided to us. At that point we could be open for a full 24 hours, leveraging your money, and adding some of our own money. Since 2019 the library has been a 24-5 environment. 24 hours a day during semesters including late night weekends. Because of the ASNAU 23 Fee, and our collaboration, we can provide a safe working and learning environment for 24 hours a day. I am going to go over a bit about the services we're offering. Our current operating hours just so you know, these hours have existed all through the COVID pandemic, these hours are what we operated with last year as well. We are open 24 hours Sunday through Thursday. We close at midnight on Friday and Saturday. In the next 24 – five, particularly in the late-night hours, students have access to a student/staff inclusive safe working environment. Which is 24 hours a day, particularly overnight, which is where your ASNAU 23 Fee dollars are going to support. We have research support 24 hours a day, ask us desk, chat, phone, text, email. Any communication that can get students to speak with us, we can provide them directories or spaces. We don't close off spaces to make it open for 24 hours, it's important to us that the experience the students get at 3 am is comparable to the experience they would get at noon. If you want to use virtual reality at 3 am, which we have had students do, you can feel free to do so. I want to highlight our creation stations, our maker lab, we do have a self-service 3D printer that a lot of our students are using. One of our more popular

options is our technology rich study rooms. Whiteboards and opportunities for our students to screencast onto the TVs in the rooms. If you do not know, we are the largest computer campus/computer lab on any new campus, we have Mac PC's. If any of you are engineering students that are familiar with the engineering computer lab, we have those computers in the library also, which has high-end engineering towers. Lastly, an unseen advantage to our partnership, is that because we're open 24 hours, we must staff the library 24 hours. Which means a lot of the services that we do behind the scenes gets students articles over to another library. They want to pick from shelf service and be able to turn that around quickly because I have more staff working around the clock. There is the walking in the library service, there is also you get things quicker and better service. Over the years, providing a safe working environment is important. We have contracted historically a third-party vendor to provide security for overnight hours. Once we went to 24/5, we flipped that and started using students to act as security. The students that apply are CJ students, all of them are applying to the job because they are Cline library users. They like the safe environment that they're experiencing, they would like to support that environment. User experience is very important to my staff, and they must use your services and experience at the Cline library, and same goes for security. A bit about financials over the year, ASNAU has historically supplied us with roughly \$60,000 a year. I have broken down a little of what that pays for, so where your dollars are going to. As I mentioned, this is a historic partnership that's been running for over a decade now. As of 2019, the library is partnering with you and having additional funding on top of that, so we can provide 24 hours access. As you can see, we have a drop, but we are back

full steam ahead this semester and students are accessing the library. My job is to provide services at the library, and to talk to you all about the services. The question comes up, “How many students are really there at the library?” I always try to make the argument that its not about the numbers, it’s about the impact. Because we all know there are far more students in the library at noon, then there are going to be at 4 am. But I would argue that those students that are here at 4 am, need to be here at 4am. If one student goes all the way to graduation because of that service, my job is done and your job is done as well. I posted a couple of comments we’ve had, also some example chats that we have with students. We are getting research requests in the middle of the night. We are getting researchers looking at our catalog and accessing our services in the library in the early morning. It’s important to note, that when you think of overnight hours, its not always about the nighttime, often times it’s also early morning right. Just to recap, we’re talking about a continuance of our partnership, the money you are providing the library is really supporting the students and loyal to student success. Does anyone have any questions?

VPGA Billings: Coming from a place of inquiry. It seems that the library has been dependent on ASNAU since 2010, the problem at hand has not been addressed. Is there a reason why there is no fee to cover the costs of the library? Thinking about the HLC, transportation, and other facilities on campus, there is a fee that is charged to everyone’s Louie account, including graduate student rooms, but there is no library fee. Just to preface, I imagine \$20 from every undergraduate student wouldn’t be able to finance the same \$60,000 that ASNAU has been partnering with you on, and it would be comparable to the donations that GSG has giving.

Andrew See: I suppose in an abstract way, they are giving to the library through the 23 fee, in the list of services they are getting, the library is mentioned there. It sounds like what you're suggesting is that they should be a separate 23 fee and library fee. I don't know the reason there hasn't been, I think there is some value to that. Maybe it was an administrative decision that students couldn't bundle the fee.

VPGA Billings: Can you say that the library fees are something that you feel might be something you didn't feature, I want to preface with, since student enrollment, especially undergraduates has been declining. The \$60,000 that is taken from the ASNAU budget through the 23 fee is making a bigger impact on the overall budget for ASNAU.

Andrew See: I would speak on behalf of myself and not library administration, the things that the library offers, the services that are offered I well beyond just that. We spend astronomical amount of money on resources, so when you're googling here on campus, looking for articles to write your paper, you access that article, a lot of time it's not what Google provided, since you're connected to the campus wi-fi you're pulling from the library catalog. Those resources cost a lot of money, it's a hidden cost, because in the sense that a lot of students don't realize it. We don't realize that it's a million dollar budget to provide those articles and databases that are provided. That is not covered by the 23 fee. The 23 fee is paying for staffing, and to keep the library open in the overnight hours. Its not paying for staffing during the day, access to electronic articles, and a myriad of other things. Being able to expand on what we can offer students beyond just being open for 24 hours, which is a great service. There are a lot of other things the

library works on with a budget, we are good stewards of our money, well within our budget. The 23 fee is a small fraction, so I think there is reason to discuss that.

Senate Chair: Thank you Mr. See. I am going to let everyone know that we do have a packed agenda for the day, so let's limit the number of questions.

President Acosta: I am talking with Margo about the library fee, so that is a conversation.

Senator Fox: Because your hours are more condensed because of the pandemic, I am assuming that you have not been getting the \$60,000 from the ASNAU 23 fee correct?

Andrew See: Right now, we have not been given it at the top of the fiscal year, so we're in the middle of the fiscal year now. We were given our 23 fee last year in June. As I previously mentioned, we were 24/5 last year. The only time we shut it off briefly was during spring break and the end of spring semester in 2020.

Senator Fox: If we were to provide the \$60,000, will you be able to uphold the 24/5 again next semester.

Andrew See: Yes, we will continue to keep the 24/5 schedule.

b. Beyonce & Catherine – Housing/Neighbor Issues

Beyonce: I came to Senator Fox about an incident that happened to us on Monday. My roommate and I have been having issues with our upstairs neighbors. It started as a noise complaint, then escalated to them sending death threats to us early Monday morning. We weren't awake at the time, but the neighbor that lives next to them let us know that is what happened.

Catherine: Just to clarify, the death threat was that they had a firearm and were threatening to shoot us on campus.

Beyonce: There have been a lot of things we had to go through this week. Specifically having NAU as a whole getting the situation mediated. The reason I reached out was because NAU didn't give us any updates, which is why we had to call them Tuesday night and ask for updates, which they responded with something along the lines that we're "overreacting", and that "You two woman are hysterical and the men we are talking about are nice boys" and everything along those lines. That was irresponsible of them, and they can get as far as saying what they said is within their rights, because it was in the confidence of their own home.

Catherine: We have a recording that we gave over to the police and NAU administration, that says they wish they had their gun, which they do own, "to whip out those --- and to shoot us".

Beyonce: There are a lot of things being said, which NAU PD did nothing about. We called them and asked about our case, they said it was all a misunderstanding. NAU PD has not helped throughout this process, which is why we went to our Instagram's to message everyone who is living on campus, and friends who know that this has been happening on campus, that shouldn't be happening. There are a lot of factors that led up to this, such as our RA not being responsible enough to follow through. We had sent two emails before this all escalated, that were brushed off. The reason we are presenting this to you is to gain some public outreach, we have been in contact with the Lumberjack to get this story published and out to as many students as possible. We've also had a response to our Instagram post that this is happening to them as well, through NAU PD, it is a recurring story. I am not sure who this works with what you all stand for, I just

wanted to put it out there as well. If NAU PD noticed that we were obviously terrified, we have met with many people that aren't able to give us an update. They can't tell us anything because of federal regulations, the only way to get this resolved is if we're at our apartment with everything worked out and we're hoping they lose, and there is a general safety. We're here today to see what can be offered through your end, and maybe there is a lot that can be done, and also to get some public outreach to the campus that this is happening, and if people in the past have had similar experiences with NAU PD, we could band together and say this can't be happening anymore. To ask why this is still happening, and how this is happening to two other people where nothing was done. I was initially supposed to come here alone, but because of the meeting we had recently, Catherine also wanted to join.

Senate Chair: Thank you for that, we will open to discussions. Before that, I want to preface that I want us all to be keenly aware of what VPGA Billings said recently. We are meant to be here to inquire and talk about solutions and how we can fix the problem, as well as leave political biases at the door, and not invalidate emotions or feelings. Because what these two women have experienced is very real and obviously important to them heavily, to let's be mindful of how we conduct ourselves during this question process.

Awareness Coordinator: Thank you for bringing this to us, that is a lot to take in. I have a question, is Flagstaff PD allowed to get involved if NAU PD doesn't have any answers for them?

President Acosta: From my experience as an RA, the answer is no. Michelle is also shaking her head, so I believe that on campus situations are within the NAU PD jurisdiction.

SSA Director Best: We have something called Advocacy Committee; this can be brought up tomorrow during our meeting. What we have right now is called the student issue network, I know you brought up that other people have had similar experiences, this can bring a lot of different experiences. You could reach out to those people and (inaudible).

Senator Nielson: Have you reached out to the (inaudible) coordinator?

Beyonce: We did not. There were a lot of resources sent our way, (inaudible).

Senator Nielson: If I were you, I would file for a discrimination suit.

Beyonce: I am half Navajo and half Apache. We both identify as the LGBTQ communities. We've just had our experiences invalidated as well as being a part of the minority is very frustrating.

Senator Nielson: Absolutely, if you need that information, we can get that to you as well.

Senator Cinader: If you would like to come to the Advocacy committee meeting, I could send you that information as well. My only concern is...(inaudible).

Beyonce: That is something that we discussed and there are a lot of things that we did in such a short amount of time. We're both taking over 20 credits, we both TA for classes, we both have research labs, we usually have a lot on our plate. Sleep is the time we get back, they took away a basic human right from us, we just wanted to sleep. We talked to them before about the issue and thought we were all on the same page but now we're not. We're fine with some noise, but not when it's shouting, jumping, and screaming.

Senator Arnold: You stated earlier that NAU PD told you, you were being overreactive women. Did they say that?

Beyonce: They did not say that verbatim, but it was heavily implied.

Catherine: They did say they spoke to them and ask if they had a gun, the two boys said no. They told us that it was safe and secure, they did not search the premises, they just asked if they had a gun. Then they called them “Nice young men” verbatim.

Beyonce: Another thing the boys said verbatim was that “This was a big misunderstanding”. We are currently fearing for our lives.

Catherine: We do have our recordings of them saying they wanted to shoot us with their gun. The police have the recording too.

Awareness Coordinator: There is a social group on Facebook that has an NAU community on it, it may be helpful in creating outreach to others.

Senator Davidson: Do you have a violations (inaudible)?

Beyonce: No, federally they can't say anything, how are we supposed to know that this is to be taken care of? From what Megan Gavin said, they can release any information, so we don't know if they've had any fire violations at all.

Catherine: We filed two police complaints before the death threat.

Senator Davidson: Did you contact more than one RA?

Beyonce: Initially we contacted our RA, then we contacted our friends who are RA's. One of them advised us to go to other RA's. We thought everything was fine, until that night. They weren't being that loud, we weren't waking up as often. They said those things while we were vulnerable, asleep while in the room beneath them.

Catherine: We did speak to other RA's about the issue.

Senator Davidson: (Inaudible) If you get stories from other students, that will be able to help the situation.

Beyonce: If nothing gets done, then maybe this will be able to help policies get put in place to deal with this situation. We've simply been needing a mediator for when we go talk to them, we've also been told to go talk to them ourselves. We went to their apartment, knocked, and they weren't coming.

Catherine: I spoke to another RA and like Beyonce said, they told us to speak to them ourselves, it was the second time to speak to them ourselves. This was when they started discussing, the gun attacks. So our RA's advice lead to the death threat.

Beyonce: Every time we have tried to express these concerns to her, she rolls her eyes.

When I was trying to get something in place so that this doesn't happen to future students. How is a person like that to have a job and free housing? How does that happen? So, if nothing comes of this, that RA, and the training that has been given to RA's is not great.

Senate Chair: Senator Fox and then we are going to go to Executive Assistance Gilbert.

Senator Fox: Hi again, very nice to meet you Catherine, I wish under different circumstances but I wanted to ask you guys because I know I have heard from a couple of RHDs that have reached out specific to this issue which is to your point but I I have also been in contact with RAs who have said that a lot of their agencies are on this situation. But I know you were looking into contacting your RHA in South Village. Have you heard anything back from them?

Beyonce: Yeah, we got an email today from them.

Catherine: He said that these were the type of vibes they were trying to have at SoVil.

Beyonce: He said vibes, verbatim. Just to put that out there.

Catherine: Like I appreciate that death threats are not the vibes at SoVil but we would appreciate a little more assistance

Senator Fox: Is that all that they said to you?

Beyonce: He said to get in contact with him. I don't know what he is going to tell me, probably going to be a whole lot of nothing yet again. I am sure there's many people working in our favor here, but it kinda feels like nothing is getting done.

Senator Fox: One thing that I will say, so sorry I'm sure that's like three follow-ups, I sent you an email last night about quiet hours. I would bring that up and see if any of the other people around you are also experiencing the noise complaints as much because that is a legal agreement from what I was told with the renter and a landlord. That is something that is guaranteed is that you will have quiet hours which they have been in violation of and I know that you have video recording of them being in violation of that.

Beyonce: Yes.

Senator Fox: So when you get in contact with your RHD you can show that to him as well.

Senate Chair Carter: Any other comments or questions for? Alright, well what I will say is Senator Fox is if people feel comfortable sending their emails potentially in the group me so that other senators in this room, if you are passionate about this issue or want to reach out to amplify their message, please reach out to them, and I know you're also

going to be getting in contact with Senator Cinader to go to Advocacy Committee. Where they also have a team of senators and staff members to really focus on certain issues so to help you know that we hear you, we speak to you, and we really really appreciate you being so vulnerable with us. I mean it is not easy and we know that the situation that you're going through right now is really, really detrimental to, like you said, your studies and stuff, so we will work with you to get some justice.

Beyonce: Thank you so much, thanks for having us.

Unfinished Business

a. SB 34-22: NAU Cheerleading Team

Senator Davidson: I move to bring SB 34-22 to the table.

Senator Cinder: I second

Senate Chair Carter: Perfect. It has been moved by Senator Davidosn and seconded by Senator Cinader. If you want to come up and discuss to us the purpose of the reimbursement, the amount and all that kind of stuff.

Representative from the Cheerleading Team: Hi, this is my first time here. We were qualified to go to the University of Arizona to represent our football team on September 18th and we stayed until the 19th. We are going for reimbursement for \$400 for gas to get to and from there.

Senate Chair Carter: Perfect. It looks like its not on the last page of the packet, it's also not on the digital one so sorry but are there any questions or comments about this senate

bill reimbursement? Right, if there are no questions then we will go into the... Oh,
Senator Fox.

Senator Fox: I am so sorry, this is just logistical stuff, but the date is not correct.

Senator Shelley: It is the Appropriations date.

Senator Fox: I thought it was supposed to be the senate date like we talked about in appropriations to make them uniform?

Senate Chair Carter: Alright, does a senator want to make a motion to amend this senate bill to read November 4, 2021? You're welcome to speak out.

Senator Handlong: I also wanted to add that there is a period missing on the final whereas. I would want to do that in the same amendment. (inaudible)

Senator Fox: I move to amend SB 34-22 to read November 4, 2021 on the top and 11/4/2021 at the bottom.

Senator Soto-Velasquez: I second.

Senate Chair Carter: Okay, the motion is made by Senator Fox and seconded by Senator Soto-Velasquez. The motion is on the amendment to SB 34-22 to change the date. All those in favor please raise your hand. Alright, the motion is carried. Are there any other comments or questions about this senate bill? President Acosta?

President Acosta: I believe we agreed that the line it would come out of was the Student Organizational Paid Out Line?

Senator Shelley: Yes I believe so.

Senate Chair Carter: Alright, is there an amendment for that?

Senator Shellye: I move to amend SB 34-22 to change the Club Paid Out Line to spread the Student Organizational Paid Out Line.

Senate Chair Carter: Perfect, is there a second?

Senator Machelor: I second.

Senate Chair Carter: So the motion is made by Senator Massey and seconded by Senator Machelor to amend SB 34-22 to instead read Student and Organizational Paid Out Line.

All those in favor please raise your hands. Alright the motion carries and we will be amending SB 34-22. Are there any other further comments or discussion? Senator Handlong?

Senator Handlong: I was wondering, in the fourth whereas this part is different from the first. Do we want to make that all the same?

Senate Chair Carter: Good question! Senator Massey, do you have a preference as the Appropriations Chair?

Senator Masey: Honestly, we could change it to how it is on the first one so that we kind of have an organizational system? A uniform system for this? I move to amend SB 34-22 to read on the fourth whereas the dates changed to September 18 and the next date to September 19.

Senate Chair Carter: Is there a second?

Senator Chandlong: I second:

Senate Chair Carter: Alright Perfect so Senator Massey moves and Senator Handlong seconds to amend SB 34-22 to change the dates, to be more in line with the other senate bills. all those in favor please raise your hands. Alright the motion carries and SB 34-22

is amended. Are there any other questions or concerns about the Senate Bill? President Acosta

President Acosta: How was it? I was there and it was historical so I want to hear from your perspective.

Representative from the Cheerleading Team: Yea we were going to the game and we had no hope and we had only taken like 6 people and we were thinking that it was going to be embarrassing. Then we had to be escorted out by security and there's really big bugs there so that was cool. But it was cool! It was exciting to be there.

President Acosta: Alright, thank you!

Senate Chair Carter: Final chance for comments and questions? Alright then the motion is on the adoption of SB 34-22 to reimburse the cheerleading team. All those senators in favor, please raise your hand. All those opposed. Right the motion carried now we will officially be reimbursing the NAU Cheerleading team. Thank you so much.

Representative from the Cheerleading Team: Thank you!

Senate Chair Carter: Alright now we're going to move into new business, starting with SB 34-23. Can I get a senator to make a motion to bring item A to the table?

New Business

- a. SB 34-23: NAU International

Senator Fox: I move to bring item a to the table.

Second Davidson: I second.

Senate Chair Carter: Awesome. The motion was made by Senator Fox and seconded by Senator Davidson. Is there a representative from the NAU International here to discuss this bill? Perfect, can I just, just quickly, point of information, do the representatives have to be here for us to reimburse them?

Senator Nielson: As long as they message a senator to present on the bill otherwise, yes.

Senate Chair Carter: Good to know, thank you for informing me. So Senator Massey?

Senator Massey: I have not heard from them.

Senate Chair Carter: So can I get a motion to table this for senate in two weeks? Or, sorry, next senate meeting?

Senator Machedlor: I move to table SB 34-23 for next senate meeting.

Senator Massey: I second/.

Senate Chair Carter: Perfect, a motion is made by Senator Machelor and seconded by Senator Massey. All those in favor of tabling this bill, please raise your hand. Alright the motions carries and we'll be coming on to SB 34-24, the Pine Pals. Is there a representation from the Pine Pales in the audience? Does Senator Massey feel up to talking about the bill?

b. SB 34-24: Pine Pals

Senator Massey: I am aware that they just had a pumpkin painting event on campus and I know that they are just requesting \$30 just for the pumpkins. But pumpkins are kinda considered a food item. I guess this is up to the interpretation of the senate.

Senate Chair Carter: Senator Fox

Senaotr Fox: Two things. First I do not know if we have to bring item b to the table?

Senate Chair Carter: Oh my lord. I kinda asked that question more as like, if we can now bring this bill to the table.

Senator Fox: That is what I thought so I just wanted to check. Second, I think if they are not using it for food, then there is no reason for us not to reimburse them. They didn't really eat the pumpkins.

Senate Chair Carter: Since it sounds like there was discussion on this item so can we get a senator to make a motion to bring SB 34-24 to the table?

Senator Massey: I move to bring SB 34-24 to the floor.

Second Davidson: I second.

Senate Chair Carter: Alright the motion is made by Senator Massey and seconded by Senator Davidson. Is there any conversation or discussion about it? Oh wait, vote, sorry y'all. All those in favor of bringing this to the floor, yay! The motion carries. Okay, now that it is on the floor I saw Senator Nieslsen you had a comment and then President Acosta.

Senator Nielsen: Yes, the bylaws do say any food item and we talked about this in Appropriations but as long as we identify that it is not a food item or a food source then that's fine.

Senate Chair Carter: President Acosta.

President Acosta: Yeah, I just wanted to clarify this food. The pumpkin has been a thing that even in my hall we had to get a food waiver to get pumpkins. So it's not whether we interpret it as a food object it is kinda up to the university at that point to still send it to them and then frame it like an object but piece of it is more university end.

Senator Arnold: Do we know if this was approved in TrueBlueConnects?

Senator Massey: It was.

Senator Arnold: The I would assume then that they would have received a food waiver? Because they would not have been able to have the event then if they hadn't.

Senate Chair Carter: Alright, Senator Fox?

Senator Fox: I am honestly just thinking about the fact that if we decline this bill and say pumpkins are food item to them I am going to feel really bad about that. I do see that point though, I feel like though with RAs because you are in the halls, I feel like there are more strict procedures that need to be followed? But again, I guess if it wasn't approved by TrueBlue then it does fall into a gray area. It is only how we interpret the bylaws, right?

Senate Chair Carter: A response?

Senator Arnold: I do not think that is in our bylaws. I am almost a hundred percent sure.

Senate Chair Carter: Okay, while Senator Fox does some research we will go over to Chief of Staff Varner.

Chief of Staff Varner: I will say that I also bought pumpkins for our Trunk or Treat and we had to fill out a food waiver.

Senate Chair Carter: Good to know. I am also just going to make it a norm now that when you are speaking and you are finished speaking please say "I yield my time" just so I know that you're done talking. Alright? SSA Director Trachsel?

SSA Director Trachsel: TrueBlue Connects specifically asks if food is being served at this event and obviously that means food consumption so maybe because the pumpkins

were being used for pumpkin painting, they marked no on food being consumed and then would get around that food waiver right up. Furthermore, authorization forms can be signed after the senate passes the bill. I have done that plenty of times. I yield my time.

Senate Chair Carter: Senator Fox.

Senator Fox: Thank you. It does not say in our bylaws that we cannot reimburse for food. It does not say that anywhere. I think at the beginning though it does say that you have to follow all university guidelines for any event. So I think if we were going to we could just pass this and like SSA Director Trachsel just said, just ask them to fill out the food waiver form. I yield my time.

Senate Chair Carter: Perfect. Any other comments or questions regarding this bill? If there are no other comments we're going to go ahead and vote on the motion to..Oh,

Senator Handlong.

Senator Handlong: I noticed in the third whereas that it says "Pine Pals did a painting pumpkins with them members in their club"

Senator Massey: I am so sorry.

Senator Handlong: I was wondering if that was something we wanted to fix.

Senator Massey: I move that SB 34-24 be amended to read "Pine Pals did a painting pumpkin event with the members" in the third whereas.

Senate Chair Carter: Is there a second? Senator Fox.

Senator Fox: I don't know, can we say pumpkin painting? I just.. I don't know... I am sorry.

Senate Chair Carter: I think, personally, that we should just carry on with a pumpkin...painting pumpkin event. Is there a second for Senator Massey's original motion?

Senator Tyson: I second.

Senate Chair Carter: Alright so the motion is on the amendment SB34-24 to instead read "Pine Pals did a painting pumpkins event with this remembers." All those in favor please raise your hands. Perfect the motion carries, you will be amending this bill. Are there any other comments and concerns. VPGA Billings?

VPGA Billings: In both the bolded "an act to allocate" statement at the top and the bottom, the top reads "for the Pine Pals" and the bottom reads "for Pine Pals".

Senate Chair Carter: Good question. A good flag. Is there any amendment for said flag?

Senator Massey: I move to amend SB 34-24 in the first bold section to read at the end "purchasing pumpkins for Pine Pals."

Senate Chair Carter: Is there a second?

Senator Arnold: I second.

Senate Chair Carter: Alright, the motion is made by Senator Massey and seconded by Senator Arnold. All those in favor of amending SB 34-24, please raise your hand. Right and the motion carries and we will be amending the bill. Senator Handlong?

Senator Handlong: I hate to be so picky, I am sorry but in the very top it says Paid Out line and line is not capitalized as it is on the bottom. So I wasn't sure if we wanted to do anything about that.

Senator Massey: I move to amend SB 34-24 to capitalize line on the first bold section.

Senator Handlog: I second.

Senate Chair Carter: Alright Senator Massey motions and Senator Handlong seconds. All those in favor of amending SB 34-24 to capitalize line please raise your hand. The amendment carries. Are There any other questions or comments? Senator Cinader?

Senator Cinader: This is more of just a point of clarification. Could we pass this bill with like a condition that they have to get like a food waiver in like three weeks? Could we do like a three weeks and if they do not get the food waiver before we reimburse them?

SSA Director Trachsel: The university will not fund it until they get their food waiver in. So getting the money in any case is literally conditional.

Senate Chair Carter: Good to know. Senator Nielson, did you have anything?

Senator Nielson: No.

Senate Chair Carter: Okay, Senator Fox.

Senator Fox: I am so sorry. The date is the 4.

Senator Nielson: So I should have mentioned this on the first bill, we decided that the date was going to be the date it went through Appropriations and not the date that it passed through the senate.

Senator Fox: Oh my bad then. Alright then it is good!

Senate Chair Carter: We will fix it for that other bill do not worry. Oh someone just had to get out of here. Okay, is there any further conversation about SB 34-23. Okay then we are going to go ahead and move into the voting period. The motion is on the adoption of SB 34-24 to reimburse the Pine Pales for pumpkin painting. All those in favor please

raise your hands. All those opposed. Okay the yays have it and the motion is carried. You will be reimbursing the Pine Pals.

c. SB 34-25: oSTEM

Senate Chair Carter: Okay, is there a representative from oSTEM in the building? Senator

Massey: They were on zoom. I saw them.

Senate Chair Carter: Okay well we can just go to the next one then.

Senate Chair Carter: Okay, can I get a motion to table SB 34-26.

Senator Davidson: I motion to table SB 34-26.

Senator Cinader: I second.

Senate Chair Carter: The motion is made by Senator Davidson and seconded by Senator Cinadner. All those in favor of tabling SB 34-26, please raise your hand. The motion is carried. Thank you we're going to go on to SB 34-27, item e. Can I get a senator to motion to bring that to the table?

SB 34-27: COS Bill

Senator Davidson: I move to SB 34-27 to the table

Second Massey: I second.

Senate Chair Carter: The motion is made by Senator Davidson and seconded by Senator Massey and this looks like a bill from our Chief of Staff. Would you like to speak out a little bit more on it? You're welcome to sit there.

Chief of Staff Varner: It is basically just ASNAU sag. We are running out now that we do not have KMA shirts. We have some stuff left but if you wanna see what it looks like there are stadium cups, tote bags, keychains. We are still waiting on one other thing. But I can also show you after the senate if you are interested. But it has our official logo on it. Sorry, I know it is not very big. Yeah, are there any questions for me? Senator Fox: Just because you said that other forms were coming from other funds, I was wondering if anyone knows if we have to clarify that because I feel like we are going to have another bill specifying the rest of where you are going to get that money? Senate Chair Carter: Good questions. VPGA Billings.

VPGA Billings: Any staff can use their right to initiative without the senate. It is only if it is over \$750, that's when it gets. So for, example, awareness coordinator can use \$500 for events without having to go to Senate. (inaudible)

Senate Chair Carter: Question follow up?

Senator Fox: Just because the amount that it says total cost is \$2500 and the amount you're getting is \$1500. So, will we need another bill to go to senate? Just for understanding purposes.

Happy Bones Day everyone! This week I have been working on the proposed tuition resolution. I received help from Senator Fenn, Executive Assistant Gilbert, and SSA Director Trachsel. We are moving forward with different ideas on how to address this issue. I also met with Kyle Nitchke from ASA to go over some of the numbers, and have updated some of the Senators working on this project with me about the total collections for ASNAU. I have also been working on a formal policy proposal for the Election Day resolution. My goal is to finish the draft by next Thursday. I plan to run it by all the execs before they sign onto it. This is also open to any Senators who also want to look at this proposal before we send it off, I will have the draft in Teams once it is complete and y'all can give your input on it or meet with me. Today I attended the NAU Votes Coalition meeting. We are looking at ways to increase voter registration starting next semester. We also discussed the NSLVE Report for voter turnout on-campus in 2020. Overall, voter registration on campus is 82.3% of all eligible voters, this is up 5% from 2016's Presidential election. The voting rate of Registered Voters is 75.8% which is 62.3% of all eligible voters on campus, this is up 16.4% from 2016. In all of these categories we greatly surpassed our goal for turnout in 2020 and are looking for ways to keep this momentum in the 2022 midterms. Voting rates by college: CEdu 66%, CAL 65%, CEFNS 64%, HHS 63.7%, SBS 63.1%, WAFCB 58%, and CEIAS 51%. Voting turnout by college: SBS 4055, HHS 2911, WAFCB 2468, CEdu 2419, CEFNS 2257, CAL 1485, CEIAS 1229. 26% of students voted early in-person, 11% voted in-person on Election Day, and 61% voted not in-person through mail, which is a significant change, likely due to COVID. The AZ Supreme Court ruled that the AZ Legislature illegally passed a ban

on mask mandates, this means that localities in the state can continue to enforce and require mask policies. The Supreme Court also struck-down several new election laws from the AZ Legislature that were targeted at limiting the Secretary of State's powers, especially around election integrity and the power to defend election laws in court. The Supreme Court also ruled against the State Legislature again, striking down a rule that would require ABOR and the AZ Superintendent of Public Schools to get approval from the Legislature's before spending certain federal funds; likewise the State Supreme Court also struck down a law that allowed the attorney general to press charges against any teacher or school employee for teaching critical race theory or gender studies. ABOR is coming up, two weeks away. I yield my time.
