They were concerned about some of the language being a little to heavy handed for the university. They asked us to go through with one of the faculty senators to work through the sections. It still has all the original meaning; it just has a little different wording. Some of the whereas points have been moved as well. If you have any questions, Senator Tyson can also answer. Some of the key points are, that we should praise the university for having the first environmental science degree programs. We should also make it clear in the declaration that there is a partnership between NAU and The City of Flagstaff, rather than one being dominant over the other. On top of that, we also made the Green Jacks a co-sponsor of the resolution, because they have worked tirelessly on this.

Senator Fenn: I know that there was a goal to be carbon neutral by 2020, do you know why this was delayed?

Green Jacks President: I do not know the full reason; I think it was just lack of effort to decrease carbon from NAU.

Chair: With the change in presidents, there were changes in priorities.

Senator Fenn: The name for Senate Chair is different, was that a mistake?

Senate Chair: The name in the packet will be different than the one on the screen.

VPSA Kavanaugh: I just want to make sure that before we pass this, Green Jacks is in

support of this resolution. (Yes).

Senator Arnold: On the top of the resolution, one of the sponsors is "Senate Chair – Jacob

Carter", isn't the senate chair normally a sponsor? I just don't remember.

Senate Chair: I put my name on there with my new title since we are amending the

resolution, we are also doing something unprecedented by adding the Green Jacks as the

sponsor. I don't think there is any problem with this, this is a resolution that I worked on

Hi everyone, I apologize for how long this is going to be so I am going to try to keep it as short as possible, but I have a lot of major updates. First, the Student Resource Guide is finished. It has been posted on teams and I encourage you all to take a look and if you see any resources that you know of not on there, please let me know and I will add them. We will now be advertising and finalizing URLs for the website. Second, I have gotten confirmation from the Head of Academic Advising and the BBLearn and LOUIE Supervisor that we can now start building a LOUIE Training. In the next few weeks, LOUIE is getting a massive over hall, so we are going to be creating new trainings for the updated LOUIE, which is something that is going to be desperately needed. The BBlearn director has also agreed to make the LOUIE training a mandatory training on BBLearn like the Academic Integrity Module. This will reach every single student on campus and provide an easy way to become familiar with the system. If all goes well, advisors will now require this training before you

are allowed to meet with them. Finally, I have some big news on the Meal Plan project that I have been working on. I met with TC, the head of campus dining this Monday and presented him 5 potential solutions that the advocacy committee, VPSA Kavanaugh, and I worked on for the past couple months. Out of the 5 presented Campus Dining has agreed to 4 of them. Just to clarify, they are now going to try to implement these new solutions, but if there are major roadblocks or issues, they may not make it to implementation next fall. But with, here are the four things that may be changing with campus dining and meal plans. First, campus dining is considering offering a 7 meal per week option. It will either be added on to the existing 10, 14, and 19 meals or the amounts will change to 7, 12, 19. This will give students more options on meal plans and allow those who felt that 10 was too many to have a smaller, cheaper option. Second, there will be transfer donations. If you have meals left over at the end of the week, you can donate them to the meal swipe program which provides meals to those who are in a food emergency and need immediate assistance. Currently this program is in Beta Testing where all the donated meals were provided by Sodexo just to test and make sure the system is equitable and working properly. Assuming all goes well in Beta Testing, in the fall 2022 semester you will be able to donate your extra meals to those who need it. Third, LOUIE Cash will be making a comeback. You will be able to use your JDE to pay at restaurants off campus like downtown or by the Walmart. This will provide students with more

options and especially those with dietary restrictions. Campus Dining will try decreasing the buy in price for restaurants to make it more appealing to restaurants. This program will restart as soon as they have enough restaurants to justify restarting the system. Finally, the dietary opt out process is going to get a massive overhaul. Instead of being a question of medical vs preference deciding whether you are allowed to opt out, the bar is going to be set as whether you can maintain a healthy variety on campus. Also, the decision of whether you can opt out of the meal plan will no longer just be decided by disability resources, but it will be done by a committee consisting of Campus Dining, the Campus Dietitian, Disability Resources, and a select few students from organizations like SHAC and ASNAU. The final change is with the required doctors note that you would need to opt out, which really limited who could opt out. I could not convince them to remove the doctors note because they need it for liability reasons and to ensure people don't cheat the system. But we came to the compromise of getting campus health to provide either free or very affordable consultations to those who don't have health insurance or need a more convenient option. This is a large change so it may take more time that the rest to be implemented. All four are massive changes that will greatly change how campus dining operates and fix some of the issues that were expressed to us just earlier this year. And again, these changes are entirely dependent on campus dining's ability to implement these changes without any major roadblocks. But I will stay on them and make

sure as many as possible are implemented. That is all from me, I apologize again for such a lengthy report especially today, but these updates are major and needed to be shared. Thank you and I yield my time.
