a. Anika Olsen, VP of Enrollment Management – NAU Enrollment Deposit

Motion to bring ITEM A to the floor.

Motion passed to bring ITEM A to the floor

Anika: Good after noon. I am from enrollment management team for the university. The one fee that is charged to all undergraduate students. So everyone here have paid that fee. I am asking for support for a raise of this fee. For the school year (2023). This fee was first established in 2007, when it was \$200. In 2014, it was changed to \$225. And recently, it was changed to \$250, which is what it is currently. You may have paid more than 250, because we used to bundle that into other fees. However, we had to split that fee since after 2020 enrollment year due to student's demand. This fee pays for the in-person orientation person for students and parents. It pays for 2/4 full-time staff in the admission office, all True-Blue ambassadors. Moreover, we also have to pay for the buses to use in the tour, besides the gas money. Why are we changing that now? The cost for clubs and organizations has been increasing. Jackscard migration to digital cost us more money. Any students who receive the Pell grant can move this fee to be paid later with that financial aid. We are weaving international students into this fee. The international program is about a week long and traveling fees for those students are also included. So I am asking your support to increase the fee from \$250 to \$325. This fee is solely for covering fees that has been occurring. It is a budget-neutral change of the fee. My goal is to not come back for another 5 to 6 years asking for support in this cost change. The other big piece is starting in fall 2023, application fee will not be charged for first time students on the flagstaff campus.

President Acosta: University of Arizona charges \$450, not including gas. Arizona State University charges \$300, not including gas. It is still within a good level compared to other universities in Arizona.

Anika: We do not charge people for having guests at the orientation. University of Arizona charges \$50 per guest to attend the online orientation. We do not change extra for guest.

Senator Machelor: Instead of 25 increments, it is a \$75 change. Is that a change for security or is that a calculated number that we ended up with?

Anika: Inflation. There are also a few dynamic views to this change. For example, the orientation was multi-lingual so that we can be inclusive. Couple of forces drive the number. We did run the number in a lower amount, and we just continue to find other areas in enrollment to make it work.

Senator Fox: About the Jackscard, currently, on iPhone users can benefit from it. What about other people who may not have an iPhone?

Anika: By 2023, it should be implemented for everyone.

Senator Fox: Will students be receiving a physical card?

Anika: It is the student's choice. Either way, it will be included in the fee.

Senator Fox: I was wondering about the international students. How much of that fee will help out the international students?

Anika: We have been accounting for 100-200 international students. It also accounts for staff and other fees associated with the international programs such as transportation cost for those students from the airport.

Vice Chair Trachsel: About the Jackscard. All those costs are for infrastructure, not just the physical cards right?

Anika: Correct. The cost is for paying fees for apply the technology and other companies to have the application running. Staff, and associated fees to keep the digital cards going. There was a start up cost and annual cost to keep things going. My email is here (Anika.Olsen@nau.edu). Please email me if you feel strongly about this matter, we would like to quote you in in our meeting with ABOR to make this change. Next week, I will join with the President along side with senior vice president to present the broader vision for tuition and streamline fees voting along side with the enrollment fee. What we present next week will be more in-dept Chair Carter: You mentioned the application fee, could you touch on that more?

Anika: We have more than 50,000 application fees for undergraduate, graduate, international, transfer, and online. We have been waiving the application fee for students coming in as a strategy to welcome students. The application fee is \$25, and the other institution are \$50. First time students at NAU are not required to pay application fee. This is only for residents of AZ Chair Carter: Does this change account for wages increase?

Anika: It does. I do anticipate over the next year or two, we will see increases for student wages. President Acosta: Do we want vote to support this change today?

Senator Fox: I say to wait until next week.

Anika: We would want formal student feedback. So this meeting does not need a formal student vote.

VPGA Billings: I agree on waiting until next week.

b. SB 34-66 NAU Club Baseball

Motion to bring ITEM B SB 34-66 to the floor

Motion is passed to bring ITEM B SB 34-66 to the floor.

Senator Fox: They are asking for reimbursement for National Club Baseball Association fees. The association will assist the team for fundraising, discounts for equipment, sport uniforms, which are useful for the team. They also organize conferences to compete against other teams. Basically, they are asking for up to \$2,000 reimbursement. I'm saying that because the registration fee is \$1,700.

Senator Nielson: Why are they asking for \$2,000?

Senator Fox: They are asking up to 2,000. So we would reimburse whatever they turn in in their receipts.

Senator Nielson: Do we know what exactly they ask paying?

Senator Fox: they are asking for up to \$2,000 because they do not know if there is a tax attached to that.

Senator Nielson: since we do not know what we are reimbursing, we should sustain this until next week for clarification form the club.

Senator Cinader: Is this just registration fee?

Senator Fox: Yes. This is a membership in a way, because it will benefit the club.

Motion to table ITEM B SB 34-66 until next week

Vice Chair Trachsel: I totally understand Senator Nielson's concern. I think it is unusual to table because we have been reimbursing other bills in this manner.

Senator Nielson: They have to turn in their receipts upfront. I think this would be politically correct way to process this matter.

Chair Carter: for clarity, a previous bill asked for \$1,300 and they had turned in their receipt. So, at the end, they were only reimbursing about \$1,200.

Senator Handlong: My concern is that it is not clear what we are reimbursing. Knowing what those fees, what it is we are paying for is crucial. These specifics are also on the previous bills. So having the specifics would be more helpful.

Senator Fox: I do not know how the fees could be worded. This reimbursement would only allow them to participate. Whatever they get out of the membership is entirely separate from us.

Senator Muneno: They did not tell you the specific fees?

Senator Fox: When people ask for the full amount. I always look for whether it is more or less than what they asked for. What I found out is that it is \$1,700 per team.

Chair Carter: Is it possible to have a representative from club for clarification?

Senator Machelor: I emailed them to attend the meeting. But they were not able to attend President Acosta: This reminds me of my sorority fees. Would we reimburse someone's sorority fees based on this discussion? Since the sorority is helping the individual grow.

Senator Arnold: I agree with Acosta. I do not understand why we should pay for association fee. Chief of Staff Varner: Since they are asking for a large amount, I think they should put more effort in explain the fee.

Senator Machelor: Conference fee is also under the association fee, and we have reimbursed many conferences before.

Senator Nielson: What did they say in the Senate Bill?

Senator Fox: They said: "the purpose of this event is to pay yearly fees to participate in the

National Club Baseball Association."

Senator Alueta: Is this a yearly fee or is this just a one-time fee reimbursement? Senator Fox: I do not know. Though we do not set precedent on reimbursing fees.

Senator Cinader: Do you know if they are doing fundraising?

Fox: I do not know but I can get back to that.

Senator Cinader: Do u know when is the fee due?

Senator Kolasinski: I cannot find the website for the organization. I yield.

VPGA Billings: The other thing to table this, they would have to provide the receipts anyway. Tabling this bill will not devestate them. I would like to call for a motion to table this bill.

Alexis Soliven: The tools include disposable make up tools to keep thing sanitary.

President Acosta: what the t-shirt will be used for?

President Acosta: I believe that the shirt has to be available for the student only to be reimburse.

Vice Chair Trachsel: Are you still giving some shirts away?

Committee Reports

a. Appropriations Committee: Senator Fox, Senator Machelor

This week we reviewed three bills and had a vote by proxy on a bill we needed to present to senate today, the COSGA bill. We had also received some concern by students on why their reimbursement has not passed: this semester and last. We are always more than willing to meet with them to discuss our decision, so if any of you ever receive an email with concerns like these, please let Senator Fox, Senate Chair Carter, and I know. We understand that our bylaws may be confusing since it is up to interpretation of that years' ASNAU Appropriations and ASNAU Senate but clarification and/or discussion can always help. Since the office is closing the last week of April the last day for reimbursements is the 21st of April 2022 so we can get everything in during the last senate meeting. Another topic is we will not be reimbursing Graduate exams that occur after April 22. In order for us to process and give the reimbursement the graduate exam must be held April 21 or before. Lastly, I attended the lovely Legislative Committee this Tuesday to present on the bill writing process. If you weren't able to attend Senator Handlong uploaded the recording under Senate and Files. Hello everyone! I first would like to give a huge thank you to Senator Machelor coming
to committee this week to do a Bill Workshop with us, it was incredibly insightful and

posted to the Senate feed in Teams for those of you who would like to watch it or missed

this week's meeting. As for amendments of the By-laws, we are continuing our project of the Job classifications, and have changed both Articles 2 and 4, regarding the duties of the Student Body President and Vice President of Student Affairs. While Senator Kolasinski was a member of the committee, she worked diligently to update the Duties of the President and added or changed things according to President Acosta's suggestions. I would love to welcome either of them to speak on this if they would like. As for Article 4, Senator Arnold spoke with VPSA Kavanaugh to update the Duties of the VPSA position as shown. We removed the subsections of section 2 that previously discussed the VPSA serving as a Legal Aid for students and changed "the student affairs committees" to instead read "High Pines committee." We also made a clarification in section 8, and removed "in conjunction with the Chief of Staff" from section 14, due to that no longer being necessary. VPGA Billings: Only if they want to pull money from ASNAU.

President Acosta: If it is a single purchase that is over 750, then they need to write a bill Senator Fox: You said that you can bring some money out of your own line. But you also need to bring it to senate because you were also pulling the money out of the student's organizational line. So I was wondering if we can rehash that to get to the bottom of it.

Chair Carter: We can organize that conversation outside of senate before bringing ti back in. Senator Handlong: If we remove in conjunction with the Chief of Staff. Would we have to remove it from other Articles as well?

VPGA Billing: Yes, consistency is key. Though Chief of Staff Varner and President Acosta would be the one who oversee chief of staff' staffs.

Chair Carter: We should discuss this before bringing this to Senate.
