Pima County: Transient lodging in unincorporated areas of Pima County is subject to a 6% county tax (effective 1/1/06). This tax does not apply to transient lodging located within the incorporated cities/towns of Pima Co. The 0.55% Transportation Excise Tax (eff. 7/1/06) applies to all transient lodging businesses in Pima County.

Note: Communities in **Bold** text reside in two counties and therefore appear on the list twice. Those communities are: Apache Junction, Queen Creek, Sedona & Winkelman.
